## CONSENT ORDER

The Petitioner, State of Oklahoma, ex rel., Department of Consumer Credit ("Petitioner") and the Respondent, Camping World RV Sales, LLC, ("Respondent") voluntarily enter into this Consent Order as an informal disposition of this individual proceeding to avoid litigation. The Respondent agrees to waive its right to a hearing under the Oklahoma Administrative Procedures Act and both parties agree as follows:

- (1) The Petitioner restates and incorporates by reference the allegations made by the Petitioner in the Notice of Hearing filed in this matter.
  - i. The Respondent is registered as a foreign limited liability company in the State of Oklahoma, Oklahoma Secretary of State filing number 3712352874, active filing status.
  - ii. The Respondent transacts business at 13111 N. Broadway, Oklahoma City, OK 73114.
  - iii. On November 4, 2016, Jimmie Ray, a consumer credit examiner, entered the business premises of the Respondent and spoke to Mr. Don Dockum, Finance Manager for the Respondent.
  - iv. The examiner asked Mr. Dockum if the location offered in-house financing. Mr. Dockum stated that the financial contracts are completed at the location. Mr. Dockum provided copies of the contract that lists Camping World RV Sales, LLC.

- v. The examiner reviewed two Retail Installment Security Agreements. Both contracts list the Seller as Camping World RV Sales, 13111 N. Broadway Extension, Oklahoma City, OK 73114.
- vi. As of December 1, 2016, the Respondent is not licensed in the State of Oklahoma pursuant to the provisions of 14A O.S. §§ 6-201 through 6-203 of the UCCC. 14A O.S. § 6-203(2
- vii. The Respondent did not file notification pursuant to the provisions of Section 6-201 of the UCCC, on or before January 31, 2016.
- viii. Respondent has failed to pay the notification filing fee of \$120.00 for each business location pursuant to OKLA. ADMIN. CODE § 160:5-1-2(2)(A).
- (2) The Respondent does not admit to the allegations made by the Petitioner in the Notice of Hearing filed in this matter, and incorporated by reference in this Consent Order.
- (3) The Respondent agrees to submit a notification filing application and pay all applicable registration/application fees to the Department, on or before January 31, 2017. In addition, the Respondent agrees to pay a \$1,000.00 civil penalty, payable to the Oklahoma Department of Consumer Credit, on or before January 31, 2017.
- (4) The payment shall be made payable by check or money order to the Oklahoma Department of Consumer Credit, shall indicate the payment is for Case Number  $16-0201-\mathrm{DIS}$  and shall be addressed to the attention of Roy John Martin, General Counsel, Department of Consumer Credit, 3613 N.W.  $56^{\mathrm{th}}$  Street, Suite 240, Oklahoma City, Oklahoma 73112.
- (5) A file stamped copy of this Consent Order will be returned to the Respondent upon signature of the Administrator of the Department of Consumer Credit or the Deputy Administrator of the Department Consumer Credit.
- (6) If the Respondent fails to comply with the terms of this Consent Order, the Administrator of the Department of Consumer Credit is authorized to file an application to enforce this Consent Order in the District Court of Oklahoma County,

Oklahoma in accordance with the provisions of 14 O.S. § 6-
