APPENDIX I. CHANGES IN DOLLAR AMOUNTS - JULY 1, 2020

(a) The percentage of change, calculated according to the nearest whole percentage point, between the Index at the end of 2018 and the Reference Base Index is ten percent (10%) or more so various dollar amounts set forth in the Uniform Consumer Credit Code shall change using figures from Consumer Price Index Indicators, Consumer Price Index for Urban Wage Earners and Clerical Workers (CPI-W).
