CONSENT ORDER

Petitioner, State of Oklahoma ex rel. Department of Consumer Credit ("Petitioner") and Respondent, Cummins Ford Lincoln Inc., ("Respondent") voluntarily enter into this Consent Order as an informal disposition of this individual proceeding to avoid litigation. Respondent agrees to waive its right to a hearing under the Oklahoma Administrative Procedures Act and both parties agree as follows:

- (1) Petitioner restates and incorporates by reference the allegations made by Petitioner in the Notice of Hearing filed in this matter.
 - a. Respondent is a domestic for profit business corporation under the State of Oklahoma, Oklahoma Secretary of State filing number 1912295311, active filing status.
 - b. Respondent transacts business at 4000 Carriage Way, Weatherford, OK 73096.
 - c. On August 25, 2017, Jimmie Ray and Michael Thompson, consumer credit investigators, entered Respondent's business premises and spoke to Jack Theyel, Finance Director.
 - d. The investigators asked Mr. Theyel if Respondent offers finance options for consumers. Mr. Theyel advised Respondent uses Ford Motor Credit, Ally Bank, and Bank of America among others as lenders for

finance sources for their consumers. Mr. Theyel advised Respondent assigns the financing to the lending institutions and has been financing for two years. Upon request, the investigators scanned copies of retail installment contracts.

- e. On January 29, 2018, Petitioner issued a subpoena duces tecum to the Finance Director of Cummins Ford Lincoln Inc. at the address of 4000 Carriage Way Weatherford, OK 73096. Respondent was requested to submit documents no later than February 23, 2018. Ten (10) Retail Installment Sale Contracts were received on February 16, 2018.
- f. Respondent has engaged or offered to engage in making consumer credit sales. The copy of the Retail Installment Sale Contract for J. Karlin lists the purchase of a 2016 Ford F150. The Seller is listed as Cummins Ford Lincoln, Inc. with the business address listed. The terms of the contract are 72 monthly payments in the amount of \$621.52 with the first payment due on November 25, 2016. Total amount financed is \$39,543.00. The interest rate is listed as 4.10%.
- g. Respondent is not a supervised financial organization or a person holding a license to make supervised loans issued under 14A O.S. § 3-501 et seq.
- h. As of March 6, 2018, Respondent is licensed in the State of Oklahoma pursuant to the provisions of 14A O.S. §§ 6-201 through 6-203 of the UCCC. The notification filing license application was received on March 5, 2018.
- i. Respondent did not file notification pursuant to the provisions of Section 6-202 of the UCCC, on or before January 31, 2017.
- (2) Respondent does not admit to the allegations made by the Petitioner in the Notice of Hearing filed in this matter, and incorporated by reference in this Consent Order.

- (3) Respondent agrees to pay a \$500.00 civil penalty, payable to the Oklahoma Department of Consumer Credit, on or before April 27, 2018.
- (4) The payment shall be made payable by check or money order to the Oklahoma Department of Consumer Credit, shall indicate the payment is for Case Number 17-0373-DIS and shall be addressed to the attention of John T. Coyne, Chief Enforcement Attorney, Department of Consumer Credit, 3613 N.W. 56th Street, Suite 240, Oklahoma City, Oklahoma 73112.
- (5) A file stamped copy of this Consent Order will be returned to Respondent upon signature of the Administrator of the Department of Consumer Credit or the Deputy Administrator of the Department Consumer Credit.
- (6) If Respondent fails to comply with the terms of this Consent Order, the Administrator of the Department of Consumer Credit is authorized to file an application to enforce this Consent Order in the District Court of Oklahoma County, Oklahoma in accordance with the provisions of 14 O.S. § 6-113(4).
