CONSENT ORDER

Petitioner, State of Oklahoma ex rel. Department of Consumer Credit ("Petitioner") and the Respondent, Hertz Car Sales, LLC, ("Respondent") voluntarily enter into this Consent Order as an informal disposition of this individual proceeding to avoid litigation. Respondent agrees to waive its right to a hearing under the Oklahoma Administrative Procedures Act and both parties agree as follows:


- (1) Petitioner restates and incorporates by reference the allegations made by Petitioner in the Notice of Hearing filed in this matter.
 - a. Respondent is an Oklahoma foreign limited liability company; organized under the laws of Delaware, properly registered in the State of Oklahoma, Oklahoma Secretary of State filing number 3712458682, active filing status.
 - b. Respondent transacts business at 14228 N. Broadway Ext., Edmond, OK 73013.
 - c. On November 7, 2016, Michael Thompson and Jimmie Ray, consumer credit examiners, entered Respondent's business premises and spoke to Robert Johnson, General Manager.
 - d. The examiners asked Mr. Johnson if Respondent had any financing available for purchasing vehicles at their location. Mr. Johnson stated that the installment contract was completed in house and then given to a

finance company or bank.

- e. On December 5, 2016, the Petitioner issued a subpoena duces tecum to Robert Johnson, General Manager, Hertz Car Sales, LLC at the address of 14228 N. Broadway Extension, Edmond, OK 73013. Respondent was requested to submit documents no later than January 3, 2017. Ten (10) Retail Installment Sale Contracts were received on January 20, 2017.
- f. The copy of the Retail Installment Sale Contract for H. Bowers lists the purchase of a 2015 Volkswagen Tiguan. The Seller is listed as Hertz Car Sales LLC with the business address listed. The terms of the contract are 60 monthly payments in the amount of \$317.76 with the first payment scheduled on July 17, 2016. Total sales price of the vehicle is \$19,065.60. An annual percentage rate of 4.99% is listed on the sale contract.
- g. The additional nine (9) Retail Installment Sales Contracts received all indicate the Seller as Hertz Car Sales LLC with the business address listed.
- h. As of December 15, 2016, Respondent is licensed in the State of Oklahoma pursuant to the provisions of 14A O.S. §§ 6-201 through 6-203 of the UCCC. The notification filing license application was received on December 13, 2016.
- i. Respondent did not file notification pursuant to the provisions of Section 6-201 of the UCCC, on or before January 31, 2016.
- (2) Respondent does not admit to the allegations made by the Petitioner in the Notice of Hearing filed in this matter, and incorporated by reference in this Consent Order.
- (3) Respondent agrees to pay a \$400.00 civil penalty, payable to the Oklahoma Department of Consumer Credit, on or before April 30, 2017.
- (4) The payment shall be made payable by check or money order to the Oklahoma Department of Consumer Credit, shall indicate the payment is for Case Number 16-0199-DIS and shall be addressed to the attention of J. Steven Coates, General Counsel,

Department of Consumer Credit, 3613 N.W. 56^{th} Street, Suite 240, Oklahoma City, Oklahoma 73112.

- (5) A file stamped copy of this Consent Order will be returned to Respondent upon signature of the Administrator of the Department of Consumer Credit or the Deputy Administrator of the Department Consumer Credit.
- (6) If Respondent fails to comply with the terms of this Consent Order, the Administrator of the Department of Consumer Credit is authorized to file an application to enforce this Consent Order in the District Court of Oklahoma County, Oklahoma in accordance with the provisions of 14 0.5. § 6-113(4).
