#### CONSENT ORDER NUNC PRO TUNC

Petitioner, State of Oklahoma ex rel. Department of Consumer Credit ("Petitioner") and Respondents, GPI OK-SH, Inc. d/b/a Bob Howard Hyundai, HOWARD-H, Inc. d/b/a Bob Howard Honda, HOWARD-HA, Inc. d/b/a Bob Howard Acura, HOWARD-SB, Inc. d/b/a BMW of Tulsa, Bob Howard Nissan, Inc., GPI OK-HII, Inc. d/b/a South Pointe Honda, Bob Howard Automotive-East, Inc. d/b/a South Pointe Chevrolet, and HOWARD-DCIII, LLC d/b/a South Pointe

Chrysler, Dodge, Jeep, Ram ("Respondents") voluntarily enter into this Consent Order Nunc Pro Tunc as an informal disposition of these individual proceedings to avoid litigation. Respondents collectively agree to waive their right to a hearing under the Oklahoma Administrative Procedures Act, and all parties agree as follows:

- (1) Petitioner restates and incorporates by reference the allegations made by Petitioner in the Notice of Hearing filed in this matter, with regards to Respondent, GPI OK-SH, Inc., d/b/a Bob Howard Hyundai.
  - a. Respondent is a foreign for profit corporation under the jurisdiction of the State of Delaware, Oklahoma Secretary of State filing number 2312372553, active filing status.
  - b. Respondent transacts business at 613 S.W. 74<sup>th</sup> Street, Oklahoma City, OK 73139.
  - c. On November 4, 2016, Sarah Reynolds, a consumer credit examiner, entered Respondent's business premises and spoke to Joshua Mills, Finance Director.
  - d. The examiner asked Mr. Mills about what type of financing was being offered at the location. Mr. Mills stated they use Dealertrak and CUDL to find financing for their customers. The contract is written at the dealership and assigned to the finance company. Mr. Mills then provided the examiner with a blank retail installment contract.
  - e. On December 5, 2016, Petitioner issued a subpoena duces tecum to Joshua Mills, Finance Director of Bob Howard Hyundai at the address of 613 S.W. 74<sup>th</sup> St., Oklahoma City, OK 73139. Respondent was requested to submit documents no later than January 3, 2017. Ten (10) Retail Installment Sale Contracts were received on March 14, 2017.
  - f. The copy of the Retail Installment Sale Contract for G. Baker lists the purchase of a 2016 Hyundai Veloste. The Seller is listed as Bob Howard Hyundai with the business address listed. The terms of the contract are 75 monthly payments in the amount of \$435.07 with the first payment scheduled on July 12, 2016. Total

sales price of the vehicle is \$34,586.25. An annual percentage rate of 4.29% is listed on the sale contract.

- g. The additional nine (9) Retail Installment Sales Contracts received all indicate the Seller as Bob Howard Hyundai with the business address listed.
- h. As of February 2, 2017, Respondent is licensed in the State of Oklahoma pursuant to the provisions of 14A O.S. §§ 6-201 through 6-203 of the UCCC. The notification filing license application was received on January 18, 2017.
- i. Respondent did not file notification pursuant to the provisions of Section 6-201 of the UCCC, on or before January 31, 2016.
- (2) Petitioner restates and incorporates by reference the allegations made by Petitioner in the Notice of Hearing filed in this matter with regards to Respondent, HOWARD-H, Inc., d/b/a Bob Howard Honda.

- f. A review of Bob Howard Honda's website showed that customers can apply online for financing.
- g. The copy of the Retail Installment Sale Contract for J. Julian lists the purchase of a 2013 Nissan Maxima. The Seller is listed as Bob Howard Honda with the address listed as P.O. Box 5138, Edmond, OK 73083. The terms of the contract are 78 monthly payments in the amount of \$375.95 with the first payment scheduled on December 29, 2016. Total sales price of the vehicle is \$29,324.10. An annual percentage rate of 7.49% is listed on the sale contract.
- h. As of February 2, 2017, Respondent is licensed in the State of Oklahoma pursuant to the provisions of 14A O.S. §§ 6-201 through 6-203 of the UCCC. The notification filing license application was received on January 18, 2017.
- i. Respondent did not file notification pursuant to the provisions of Section 6-201 of the UCCC, on or before January 31, 2016.

- f. A review of Bob Howard Acura's website showed that customers can complete finance applications online.
- g. The copy of the Retail Installment Sale Contract for A. Unser lists the purchase of a 2016 Acura TLX. The Seller is listed as Bob Howard Acura with the address listed as P.O. Box 5138, Edmond, OK 73083. The terms of the contract are 72 monthly payments in the amount of \$404.84 with the first payment scheduled on December 27, 2016. Total sales price of the vehicle is \$43,148.48. An annual percentage rate of 1.90% is listed on the sale contract.
- h. As of February 2, 2017, Respondent is licensed in the State of Oklahoma pursuant to the provisions of 14A O.S. §§ 6-201 through 6-203 of the UCCC. The notification filing license application was received on January 18, 2017.
- i. Respondent did not file notification pursuant to the provisions of Section 6-201 of the UCCC, on or before January 31, 2016.

The terms of the contract are 84 monthly payments in the amount of \$429.04 with the first payment scheduled on January 1, 2017. Total sales price of the vehicle is \$36,039.36. An annual percentage rate of 2.99% is listed on the sale contract.
- h. As of February 2, 2017, Respondent is licensed in the State of Oklahoma pursuant to the provisions of 14A O.S. §§ 6-201 through 6-203 of the UCCC. The notification filing license application was received on January 18, 2017.
- i. Respondent did not file notification pursuant to the provisions of Section 6-201 of the UCCC, on or before January 31, 2016.

Box 5878, Edmond, OK 73083. The terms of the contract are 60 monthly payments in the amount of \$318.82 with the first payment scheduled on January 10, 2017. Total sales price of the vehicle is \$25,129.20. An annual percentage rate of 4.74% is listed on the sale contract.
  - h. As of December 8, 2016, Respondent is licensed in the State of Oklahoma pursuant to the provisions of 14A O.S. §§ 6-201 through 6-203 of the UCCC. The

- notification filing license application was received on December 1, 2016.

  - f. A review of Repondent's website showed that customers can complete applications online.
  - g. The copy of the Retail Installment Sale Contract for C. Zacarias lists the purchase of a 2015 Toyota Camry. The Seller is listed as South Pointe Honda with the

business address listed. The terms of the contract are 72 monthly payments in the amount of \$374.53 with the first payment scheduled on January 10, 2017. Total sales price of the vehicle is \$27,566.16. An annual percentage rate of 15.99% is listed on the sale contract.

- h. As of February 2, 2017, Respondent is licensed in the State of Oklahoma pursuant to the provisions of 14A O.S. §§ 6-201 through 6-203 of the UCCC. The notification filing license application was received on January 18, 2017.
- i. Respondent did not file notification pursuant to the provisions of Section 6-201 of the UCCC, on or before January 31, 2016.
- (7) Petitioner restates and incorporates by reference the allegations made by Petitioner in the Notice of Hearing filed in this matter with regards to Respondent, Bob Howard Automotive-East, Inc. d/b/a South Pointe Chevrolet.
  - a. The Respondent is an Oklahoma domestic for profit corporation under the State of Oklahoma, Oklahoma Secretary of State filing number 1900579222, active filing status.

Mr. Ellis stated that they have multiple lenders they use including Bank of America, Chase, and assorted local credit unions.
  - e. Mr. Ellis was unable to provide any documentation when asked and stated that all information would have to come from the corporate office.

- g. The copy of the Retail Installment Sale Contract for W. Howlett lists the purchase of a 2016 Chevrolet Traverse. The Seller is listed as South Pointe Chevrolet with the address listed as 11063-D South Memorial Dr. Box, Tulsa, OK 74133. The terms of the contract are 75 monthly payments in the amount of \$483.34 with the first payment scheduled on December 6, 2016. Total sales price of the vehicle is \$36,250.50. An annual percentage rate of 8.55% is listed on the sale contract.
- h. The additional nine (9) Retail Installment Sales Contracts received all indicate the Seller as South Pointe Chevrolet with the address listed as 11063-D South Memorial Dr. Box, Tulsa, OK 74133.
- i. As of February 2, 2017, Respondent is licensed in the State of Oklahoma pursuant to the provisions of 14A O.S. §§ 6-201 through 6-203 of the UCCC. The notification filing license application was received on January 18, 2017.
- j. The Respondent did not file notification pursuant to the provisions of Section 6-201 of the UCCC, on or before January 31, 2016.

- d. The examiners asked about consumer auto financing offered by Respondent. Mr. Miller advised they do not finance autos in house. When asked whom they used for financing, Mr. Miller would not answer any questions.
- Examiners visited the Honda dealership next door owned е. by the same company and spoke with BJ Young, Regional Finance Director. The examiners explained to Mr. that they have visited several of the dealerships he supervises, and Mr. Young advised he would instruct Mr. Miller to give the examiners copies of what they needed to review. The examiners went back to South Pointe Chrysler, Dodge, Jeep, Ram where Mr. Miller allowed them to look at finance contracts and take a photo of one. Mr. Miller would not give the examiners a business card but they obtained one from the receptionist and took photos of the exterior of the building.
- f. A review of Respondent's website showed that customers can complete a credit application online.
- g. The copy of the Retail Installment Sale Contract lists the purchase of a 2015 Chrysler Town and Country with the purchaser information covered up. The Seller is listed as Howard-DC III, LLC with the business address listed. The terms of the contract are 84 monthly payments in the amount of \$358.76 with the first payment scheduled on January 9, 2017. Total sales price of the vehicle is \$30,135.84. An annual percentage rate of 3.99% is listed on the sale contract.
- h. As of February 2, 2017, Respondent is licensed in the State of Oklahoma pursuant to the provisions of 14A O.S. §\$ 6-201 through 6-203 of the UCCC. The notification filing license application was received on January 18, 2017.
- i. Respondent did not file notification pursuant to the

provisions of Section 6--201 of the UCCC, on or before January 31, 2016.

- (9) C. Craig Cole of C. Craig Cole & Associates has entered his appearance as attorney of record for all Respondents herein.
- (10) Counsel for Respondents accepted service of Notice and Order of Hearing on behalf of each Respondent herein.
- (11) Respondents hereby waive any and all potential claims of deficiency of notice and/or hearing requirements under the Oklahoma Administrative Procedures Act.
- (12) Respondents do not admit to the allegations made by the Petitioner in the Notices of Hearing filed in these matters, and incorporated by reference in this Consent Order Nunc Pro Tunc.
- (13) Respondents jointly and severally agree to pay a \$1,000.00 civil penalty as a full and final disposition of the incorporated allegations, payable to the Oklahoma Department of Consumer Credit, on or before April 14, 2017.
- (14) The payment shall be made payable by check or money order to the Oklahoma Department of Consumer Credit, shall indicate the payment is for their respective case number, and shall be addressed to the attention of J. Steven Coates, General Counsel, Department of Consumer Credit, 3613 N.W. 56th Street, Suite 240, Oklahoma City, Oklahoma 73112.
- (15) A file stamped copy of this Consent Order Nunc Pro Tunc will be returned to Respondents upon signature of the Administrator of the Department of Consumer Credit or the Deputy Administrator of the Department Consumer Credit.
- (16) If Respondents fail to comply with the terms of this Consent Order Nunc Pro Tunc, the Administrator of the Department of Consumer Credit is authorized to file an application to enforce this Consent Order in the District Court of Oklahoma County, Oklahoma in accordance with the provisions of 14 O.S. § 6-113(4).
- (17) Due to the withdrawal of C. Craig Cole as attorney of record for Bob Howard North Imports, LLC d/b/a Volkswagen of Edmond, this Consent Order Nunc Pro Tunc is being filed.
