## CONSENT ORDER

Petitioner, State of Oklahoma exrel. Department of Consumer Credit ("Petitioner") and Respondent, Enterprises Inc., d/b/a The Debt Clinic, ("Respondent") voluntarily enter into this Consent Order as an informal disposition of this individual proceeding to avoid litigation. Respondent agrees to waive its right to a hearing under the Oklahoma Administrative Procedures Act and both parties agree as follows:

- (1) Petitioner restates and incorporates by reference the allegations made by Petitioner in the Notice of Hearing filed in this matter.
  - a. Respondent is a domestic not for profit corporation under the State of Oklahoma, Oklahoma Secretary of State filing number 2112040271, active filing status.
  - b. Respondent transacts business at 1529 W. Gore Blvd., Ste. D2, Lawton, OK 73501.
  - C. On October 27, 2017, Notice of Hearing was sent via certified mail to Respondent's Registered Agent listed as John Windham, 607 SW 11<sup>th</sup>, Ste. 5, Lawton, OK 73501. Notice was returned from the post office stating "Moved, Left No Address, Unable to Forward."
  - d. On March 4, 2017, Geromy Briscoe, a consumer credit examiner, drove by Respondent's location and noticed their marquis offering, "Let Us Help You Get Out of

- Debt." The examiner took a photo of the marquis. The examiner searched Petitioner's licensing database and found Respondent is not licensed as a Credit Service Organization in the State of Oklahoma.
- e. Respondent's website is listed as www.lasillservices.com and Respondent has a Facebook page at <a href="https://www.facebook.com/Debt-Clinic-104123382987548/?ref=aymt homepage panel">https://www.facebook.com/Debt-Clinic-104123382987548/?ref=aymt homepage panel</a>.
- (2) Respondent does not admit to the allegations made by Petitioner in the Notice of Hearing filed in this matter, and incorporated by reference in this Consent Order.
- (3) Respondent will submit an Oklahoma Credit Services Organization application and pay all applicable registration/application fees to the Department on or before January 18, 2018. In addition, Respondent agrees to pay a \$5,000.00 civil penalty, payable to the Oklahoma Department of Consumer Credit, in the following terms:
  - (a) Respondent agrees to make one (1) monthly installment payment in the amount of \$200.00. This installment payment is due on or before January 18, 2018.
  - (b) Respondent agrees to make thirty-two (32) monthly installment payments in the amount of \$150.00. These installment payments will be due on or before the 18<sup>th</sup> of each subsequent month.
- (4) The payment shall be made payable by check or money order to the Oklahoma Department of Consumer Credit, shall indicate the payment is for Case Number 17-0076-DIS and shall be addressed to the attention of John T. Coyne, Chief Enforcement Attorney, Department of Consumer Credit, 3613 N.W. 56<sup>th</sup> Street, Suite 240, Oklahoma City, Oklahoma 73112.
- (5) A file stamped copy of this Consent Order will be returned to the Respondent upon signature of the Administrator of the Department of Consumer Credit or the Deputy Administrator of the Department Consumer Credit.
- (6) If Respondent fails to comply with the terms of this Consent Order, the Administrator of the Department of Consumer Credit is authorized to file an application to enforce this

Consent Order in the District Court of Oklahoma County, Oklahoma in accordance with the provisions of 14 O.S. § 6-113(4).
