CONSENT ORDER

The Petitioner, State of Oklahoma, ex rel., Department of Consumer Credit ("Petitioner") and the Respondent, Cowboy Gun & Pawn, LLC, ("Respondent") voluntarily enter into this Consent Order as an informal disposition of this individual proceeding to avoid litigation. The Respondent agrees to waive its right to a hearing under the Oklahoma Administrative Procedures Act and both parties agree as follows:

(1) The Petitioner restates and incorporates by reference the allegations made by the Petitioner in the Notice of Hearing filed in this matter.

- i. The Respondent is a domestic limited liability company in the State of Oklahoma, Oklahoma Secretary of State filing number, 3512389206, inactive status filing.
- ii. The Respondent was previously licensed as a pawnbroker in the State of Oklahoma; license number PB001790, initial license date of March 4, 2013.
- iii. The Respondent's pawnbroker license expired December 31, 2015.
- iv. On February 2, 2016, the Petitioner conducted an examination of the Respondent at the Respondent's business location at 215 South 14th, Ponca City, Oklahoma 74601.

v. The Report of Examination dated February 2, 2016, including findings that the Respondent engaged in making pawn transactions following the expiration of its pawnbroker's license on December 31, 2015, as follows:

- (a) Ticket number 1064, dated January 4, 2016;
- (b) Ticket number 1065, dated January 5, 2016;
- (c) Ticket number 1066, dated January 5, 2016;
- (d) Ticket number 1067, dated January 5, 2016 and
- (e) Ticket number 1068, dated January 5, 2016.

vi. The Report of Examination dated February 2, 2016, including findings that the Respondent failed to obtain a written declaration of ownership on the following pawn transactions:

- (a) Ticket number 1080, dated January 25, 2016;
- (b) Ticket number 1083, dated January 27, 2016;
- (c) Ticket number 1084, dated January 27, 2016;
- (d) Ticket number 1087, dated January 28, 2016;
- (e) Ticket number 1088, dated January 28, 2016 and
- (f) Ticket number 1093, dated January 23, 2016.

vii. The Respondent was re-licensed as a pawnbroker in the State of Oklahoma on January 14, 2016, license number PB001850.

(2) The Respondent does not admit to the allegations made by the Petitioner in the Notice of Hearing filed in this matter, and incorporated by reference in this Consent Order.


(3) The Respondent agrees to pay a \$500.00 civil penalty, payable to the Oklahoma Department of Consumer Credit, on or before May 16, 2016.

(4) The payment shall be made payable by check or money order to the Oklahoma Department of Consumer Credit, shall indicate the payment is for Case Number 16-011-DIS and shall be

addressed to the attention of Roy John Martin, General Counsel, Department of Consumer Credit, 3613 N.W. 56th Street, Suite 240, Oklahoma City, Oklahoma 73112.

(5) A file stamped copy of this Consent Order will be returned to the Respondent upon signature of the Administrator of the Department of Consumer Credit or the Deputy Administrator of the Department Consumer Credit.




