- 1.1 Call to Order: Meeting was called to order by Wayne Britton, Mayor.

- 2.6 Approval to hire Jared Martinez as an unpaid Reserve for the Binger Police Department: Bobby Lynn, Chief of Police, informed the Council that the City Manager of Anadarko would not allow Jared to work in another location while employed by the City of Anadarko.
- 2.7 Consider selling or renting the Town's property located in Block 26, Lot 24 on West Main Street: Roy Stone made a motion to rent the property with Paula James approved to negotiate a price for the rent. Chalkie Opitz seconded the motion. Roy – aye Wayne – aye Chalkie – aye Motion carried.
