Message from the Chair

2016 Legislative Session Brings Challenges and Changes to the Board

The Oklahoma State Legislature went into session on February 1, 2016 with the unenviable task of trying to find cuts in expenditures and additional revenues to keep the state afloat for another year. Most likely, no one will escape unscathed and the effects of the legislative activity this year may personally affect each and every one of us individually, our businesses, and state agencies – such as this Board.

Although the State Board of Licensure for Professional Engineers and Land Surveyors is a non-appropriated, fee based agency, the cuts and budget reductions could affect all of us equally. Governor Mary Fallin issued an Executive Order late

last year freezing all out-of-state travel for state agency representatives unless approved by the Cabinet Secretary of each agency. Even though this board is not appropriated by the state, it is still bound by this Executive Order and will only be allowed to attend NCEES meetings as funded delegates of NCEES, which will certainly hamper its ability to participate nationally on matters regarding the advancement of licensure and examinations. Other budgetary cuts may follow that would affect the Board's ability to operate in its current fashion and challenge us to find ways to reduce costs and improve efficiencies.

Other legislative changes that may occur this year were requested by the Board and include proposed revisions to Title 59, 475.1 et seq, which would modernize the Board's practice act and allow us to adopt some of the progressive provisions that would bring us a little closer to the NCEES Model Law, while still allowing the Board to retain provisions that are important in Oklahoma. The original proposed statute revision was emailed to all licensees for comments and input. Since that time, the provision regarding a title act for "S.E." has been stricken from the bill due to legislative opposition. Also, the provision for limiting the number of continuing education credits allowed using online providers has been stricken. The remainder of the proposed revisions are still intact and currently moving through the legislative process.

At particular times during the legislative process the proposed language could be amended, stricken, or the bill could be voted up or down. In other words, things move quickly during the legislative session and we will keep you posted as to the status of this proposed legislation on our website at www.pels.ok.gov or you may email khart@pels.ok.gov if you have specific questions.

NCEES hosts future of surveying forum

The NCEES Future of Surveying Forum, held January 22 in San Diego, California, brought together representatives from 18 surveying-related organizations to identify key elements and strategies to strengthen the future of the surveying profession. This is the first time organizations with varying perspectives on the profession have come together to discuss its challenges and collaborate on increasing the number of professional surveyors.

A significant element identified during the forum is improving the image of the profession. Participants believe boosting the profession's image and increasing public awareness will help keep surveying relevant in the future. Other important elements include addressing changes in technology and the varying definitions of the practice of surveying.

Some of the strategies identified to address these elements include rebranding the profession to promote an updated image and increase public understanding of surveying and developing a consistent message to support the new image.

"Collaboration within the profession is crucial to reversing the declining number of professional surveyors," explained NCEES Chief Executive Officer Jerry Carter. "Working together to create a consistent message for everyone to use will provide a more effective approach to addressing this issue. The full forum report will provide recommendations on how professional organizations can continue what we started with this meeting."

State Board and OSLS Form Joint Task Force

In conjunction with NCEES forming its Future of Surveying Task Force, the Board and the Oklahoma Society of Land Surveyors (OSLS) have formed a similar Joint Task Force (JTF) to address state issues that affect licensure as a professional land surveyor and the practice of land surveying. At its first organizational meeting on September 18, 2015, the JTF developed a Statement of Purpose which identified 4 specific goals it wishes to achieve in support of:

- 1. surveying education (including continuing education),
- 2. the advancement of professionalism and leadership development,
- 3. the advancement of the profession of surveying as it relates to public protection, and
- 4. the advancement of the public perception of the profession of land surveying.

Further, the JTF will advise the Board about potential recommendations regarding surveying regulations and will study the effects of technological advancements within the profession.

Shawn Collins, PLS, was elected to Chair the JTF and other members of the committee are:

<u>State Board Members and Staff:</u> Aaron Morris, PLS; Roy Entz, PE, PLS; Glen Smith, PE, PLS; Bruce Pitts, PLS; and Kathy Hart, Executive Director.

To kick off the work of the JTF, on November 3, 2015, the Board held a special board meeting with the JTF and invited Gary Thompson, PLS, Emeritus Member of the North Carolina Board of Examiners for Engineers and Surveyors, and Andrew Ritter, the North Carolina Board's Executive Director, to discuss their experience with the steps they took to include surveying emerging technologies into its definition of surveying in North Carolina and what has occurred since they completed the process.

The JTF has also begun visiting with educational institutions across Oklahoma to determine how it can assist in ensuring that we maintain and improve the educational opportunities for surveyors in Oklahoma.

DISCIPLINARY **A**CTIVITY OF THE **B**OARD

July 16 – 17, 2015

In the Matter of Kevin M. Finn, PE 19034, Case No. 2013-016; Through Final Order; For aiding and assisting other firms in offering and/or practicing engineering and for affixing his PE seal, signature and date to engineering design drawings, calculations and certificates, which were not prepared by him or under his direct control and personal supervision, Finn was found Guilty, assessed an administrative fine of \$2,000 and Reprimanded.

In the Matter of ADAPT Corporation, CA 7086 and Florian Aalami, Case No. 2014-050; Through Consent; For offering and/or practicing engineering in the State of Oklahoma without a Certificate of Authorization, ADAPT Corporation was found Guilty, assessed an administrative penalty of \$1,000 and Reprimanded. For offering and/or practicing engineering in the State of Oklahoma without a Certificate of Licensure, Aalami was found Guilty, assessed an administrative fine of \$1,000 and ordered to Cease and Desist from offering to practice and/or practicing engineering until such time as he has been issued a Certificate of Licensure to do so.

In the Matter of Marshall Surveying Company, CA 2261 and James B. Marshall, PLS 113; Case No. **2014-081; Through Consent;** For acts that evidence a disregard or indifference towards the rules or statutes governing the practice of land surveying, Marshall Surveying Company was found Guilty. For failing to file Certified Corner Records with the Archives and Records Division of the Oklahoma Department of Libraries within 90 days, for acts that evidence a disregard or indifference towards the rules or statutes governing the practice of land surveying, and for signing and sealing a survey which was not prepared under his direct control and personal supervision, Marshall was found **Guilty**. Marshall Surveying Company and James B. Marshall were assessed a total administrative fine of \$5,000, placed on **Probation** for a period of one (1) year, and **Reprimanded**.

In the Matter of Mission Critical Partners, Inc., Case No. 2014-101; Through Consent; For offering and/or practicing engineering in the State of Oklahoma without a Certificate of Authorization, Mission Critical Partners, Inc. was found Guilty, assessed an administrative penalty of \$1,000 and ordered to Cease and Desist.

In the Matter of CES Network Services, Inc., Case No. 2014-102; Through Consent; For offering and/ or practicing engineering in the State of Oklahoma without a Certificate of Authorization, CES Network Services, Inc. was found Guilty, assessed an administrative penalty of \$1,000 and ordered to Cease and Desist.

In the Matter of Televate, LLC, Case No. 2014-101; Through Consent; For offering and/or practicing engineering in the State of Oklahoma without a Certificate of Authorization, Televate, LLC was found Guilty, assessed an administrative penalty of \$1,000 and ordered to Cease and Desist.

In the Matter of HTS, Inc., Consultants, CA 7272 and B. Darrell Morrison, PE 28089, Case No. 2015-010; Through Consent; For offering and/or practicing engineering in the State of Oklahoma without a Certificate of Authorization, HTS, Inc., Consultants was found Guilty, assessed an administrative fine of \$750 and Reprimanded. For offering and/or practicing engineering in the State of Oklahoma without a Certificate of Licensure or a Temporary Permit and for failure to submit a complete permanent PE application to the Board within thirty (30) days of the date of the issuance of the temporary permit, Morrison was found Guilty, assessed an administrative fine of \$750, and ordered to Cease and Desist.

In the Matter of Brian David Scott, PLS 1585, Case No. 2015-021; Through Final Order; For failing to comply with the terms imposed by the Board in the Final Order in Case No. 2015-025, Scott was found Guilty. In order for Scott to renew or re-instate Certificate of Licensure No. 1585, he must comply with the Final Order in Case No. 2014-025 or show cause why he cannot.

September 17 – 18, 2015

In the Matter of Timothy L. King, PLS 1534, Case No. 2015-013; Through Consent; For violating the terms of probation imposed by the Board in Case No. 2005-022 by preparing 6 boundary surveys while his ability to provide boundary surveys was on probation and for signing false notarized statements and providing them to the Board, King was found Guilty and assessed an administrative fine of \$4,000. Further,

King's PLS 1534 was **Suspended** for two (2) years with suspension being stayed for the entirety of the two (2) year period provided King performs professional land surveying duties within the constraints imposed by the Board and complete the on-line class in Surveying Ethics at New Mexico State University. The constraints imposed by the Board during and following the cessation of King's suspension are as follows: King will only be permitted to utilize his Oklahoma PLS license to offer and perform mortgage inspection reports.

In the Matter of Allen & Shariff Engineering, LLC, CA 5420 and Donald K. Beyer, PE 27918, Case No. 2015-014; Through Consent; For offering and/or practicing engineering in the State of Oklahoma without a Certificate of Authorization, Allen & Shariff Engineering, LLC was found Guilty, assessed an administrative fine of \$500, and Reprimanded. For offering and/or practicing engineering in the State of Oklahoma without a Certificate of Licensure, Beyer was found Guilty, assessed an administrative fine of \$500 and Reprimanded.

In the Matter of Pacific Aquascape International, Inc., CA 5838, Case No. 2015-016; Through Consent; For offering and/or practicing engineering in the State of Oklahoma without a Certificate of Authorization, Pacific Aquascape International, Inc. was found Guilty, assessed an administrative fine of \$750, and Reprimanded.

In the Matter of Sherwood Design Engineers, Case No. 2015-017; Through Consent; For offering and/or practicing engineering in the State of Oklahoma without a Certificate of Authorization, Sherwood Design Engineers was found Guilty, assessed an administrative fine of \$1,000, and ordered to Cease & Desist.

In the Matter of Bradley Garrett Wells, PLS 1575, Case No. 2015-028; Through Agreement; Bradley Garrett Wells elected to Surrender his PLS Certificate of Licensure No. 1575 to the Board in lieu of administrative action. Further, he shall be permanently barred from reissuance of his Certificate of Licensure as a Professional Land Surveyor in the State of Oklahoma.

In the Matter of Alber Engineering, Inc. and Jerry Wayne Alber, PE 15354, Case No. 2015-035; Through Consent; For offering and/or practicing engineering in the State of Oklahoma without a Certificate of Authorization, Alber Engineering, Inc. was found Guilty, assessed an administrative fine of \$1,000, and Reprimanded. For aiding and assisting Alber Engineering, Inc. in the unlicensed practice of engineering without a Certificate of Authorization, Jerry Wayne Alber was found Guilty, assessed an administrative fine of \$750, and Reprimanded.

November 19 – 20, 2015

In the Matter of Waylen Pont Wiseman, PE 17189, Case No. 2015-061; Through Consent; For failing to comply with the Board's continuing education requirements to obtain thirty (30) PDH's for the twenty-four month renewal period and to provide acceptable proof of attendance if audited, Wiseman was found Guilty and assessed an administrative fine of \$750. For certifying that he had completed the continuing education requirements of the Board when in fact he had not, Wiseman was found Guilty of providing false information to the Board when renewing his Certificate of Licensure, assessed an administrative fine of \$750, and will be audited in the next renewal cycle of his license.

COMPLIANCE WITH THE OKLAHOMA TAX COMMISSION REQUIRED FOR RENEWAL OF ALL PROFESSIONAL LICENSES...

Oklahoma Statutes require that a licensee must be in compliance with the Oklahoma Tax Commission to qualify to renew their professional license. If you are notified by the tax commission that you are in non-compliance, please act immediately. The Board does not have the authority to waive this requirement, so CONTACT THE OKLAHOMA TAX COMMISSION if you are notified.

JUST ASK Or Seldom Asked Questions That May Lead to Disciplinary Action

Asking for help (or directions for that matter) is often not a strong suit among engineers and land surveyors. It's not because we are 'know it all's'; it's more because of our independent and self-reliant attitude that brought us to these professions in the first place. This attitude instructs us that we should be able to apply reason, logic and calculations, if necessary, and solve any question without having to seek assistance. Experience has taught us, however, that in this 'Age of Information', there is just too much knowledge to digest and retain to keep up with the rapid rate of change. This applies equally to Board Statutes and Oklahoma Administrative Rules (OAR), which govern the practice of engineering and surveying. So, to aid our 'question asking challenged' licensees, here are some of the seldom asked questions that often lead to disciplinary action.

What Documents need to be signed and sealed?

OAR, Section 245:15-17 is dedicated to signing and sealing regulations. This office receives more signing and sealing questions than any other topic. Yet with all the questions we do receive and answer, there are still many violations stemming from improper signing and sealing. For example, a fairly common misunderstanding among engineers and/or surveyors is that plans are the only documents that are required to be signed and sealed. That is simply not the case. Documents required to be signed and sealed can be plans, surveys, specifications, reports, drawings, or any engineering or surveying work product furnished to a client, a user, or any public agency. REMINDER: The licensee's signature and seal constitutes certification that the work thereon was done by the licensee or under the licensee's direct control and personal supervision, and that the licensee accepts full responsibility and liability for the professional work represented thereon.

As a Professional Engineer - May I Practice in a Discipline that I have not listed with the Board?

The answer is unequivocally – NO. All Oklahoma PE's have been asked to list with this Board the discipline(s) of engineering in which they are competent to practice. In order to list those areas of practice, the PE's demonstrated competence in each area by one or more of the following three pathways: examination, education and experience. The Board recognizes that engineers can, and do, obtain new areas competence, and has provided the necessary form on its website for those wishing to do so. This simple process eliminates the potential of disciplinary action and harm to the public.

As a Professional Land Surveyor – How Does the Board Determine My Area(s) of Competence?

The answer to this is not quite as clear-cut. However, it should be clear-cut to the PLS who is ethically bound to make this determination. A PLS who contracts to perform a river survey, who has no education or experience regarding river surveys, is most likely practicing outside of his or her area(s) of competence.

Certificate of Authorization (CA) Requirements - In General Terms

You may practice as an individual in this state as long as you practice in your own name and do not use a fictitious name. For example, you may practice as *Jerry Jones, P.L.S.* However you may not practice as *Jerry Jones Surveying* unless you have a CA. Furthermore, the PLS or PE who signs and seals plans as a Consultant must have been hired to do work on behalf of the firm and must sign, seal and date their work and include their title block, contact information, and CA information (if applicable) on the work. Consultants may not sign and seal as the responsible charge PE or PLS for the firm to which they are consulting. As a reminder, the responsible charge PE or PLS for a firm must be a full-time employee of that firm and must meet the criteria for being in responsible charge of the professional activities of the firm listed in 245: 15-17-2 of the Board Rules. Cutting "Corners" for Professional Land Surveyors

PLS' need to ask more questions, also, especially when it comes to the filing Certified Corner Records (CCR's). One common problem that leads to disciplinary action is when the professional land surveyor fails to file a CCR where the monument is different from that shown on the existing CCR. Failure to file a CCR for that kind of substantial change can lead to confusion and ambiguity. Another seldom asked question about CCR's is exactly which corners are to be filed? The law reads in part that a record must be filed if the corner is "used as control" in a survey. Therefore, Board Rules require that CCR's must be filed for corners used in proportional measurements.

Disciplinary actions based on failure to ask questions not knowing the rules are easily avoidable. Asking other practitioners is a good idea if you are certain they are knowledgeable about the statutes and rules. Directly contacting the board, or even reading the discipline section of the Board's newsletter and learning from the mistakes of others, are both pathways to improving professional practice.
