BOARD VISITS OKLAHOMA STATE UNIVERSITY

REMAINING BOARD MEETING DATE - 2000

November 16-17

On October 11, 2000, Board Members and Staff traveled to the Oklahoma State University campus in Stillwater, OK, to speak to students to educate them as to the benefits of taking the Fundamentals of Engineering examination as soon as they are eligible and to complete the licensure process when they obtain the necessary years of experience. Approximately 130 students attended the evening meeting and listened to several speakers from the Board, Oklahoma Society of Professional Engineers (OSPE), and the Consulting Engineers Council of Oklahoma (CECO). Afterwards a dinner was sponsored by OSPE and CECO.

The Board began the day at noon with a luncheon at the home of President James Halligan, P.E. Attending the luncheon was President and Mrs. Halligan, Dean Karl Reid, Department Heads of the CEAT, Board Members and Staff, and Dr. Walt LeFevre, P.E., professor at the University of Arkansas. Dr. LeFevre was present to speak in the afternoon with the OSU CEAT Department Heads and interested faculty regarding the use of the Fundamentals of Engineering Examination for outcomes assessment. Dr. LeFevre was a co-author of the white paper on this subject and was generous enough to agree to come to Oklahoma State University to present this paper.

The Board plans to make the same presentation to engineering students and faculty at the University of Oklahoma, the University of Tulsa, Oral Roberts University, and Oklahoma Christian University later this year and early next year.

NCEES Honors Bruce Pitts and Bill Dickerson

At the recent annual convention of the National Council of Examiners for Engineering and Surveying (NCEES) held in Chicago, two Oklahoma representatives were honored for their contributions to the NCEES.

Bruce Pitts, PLS, Emeritus Member of the Board was presented the Distinguished Service Award. This award is official recognition to a member for outstanding service of a nature furthering the effectiveness of the Council in carrying out its constitutional objectives. Bruce was also awarded the NCEES Southern Zone Distinguished Service Award last April.

Bruce has been involved since 1991 with the Oklahoma Board, where he has served as secretary, vice chair, and chairman (2 terms). Bruce organized a new format for the Oklahoma Law in Surveying exam and is responsible for item preparation. He has been a member of two ABET inspection teams, and is a frequent contributor to this newsletter. He represented the Board many times before legislative bodies. He served on various NCEES committees, including the Committee on Examinations for Professional Surveyors from 1993 to present, the Law Enforcement Committee and the Land Surveying Committee. Since 1996 he has been a member of the Southern Zone Awards Committee and served as chair. Bruce is currently an item writer for the FLS exam and has represented the NCEES at the formal NAFTA meeting at the 1998 ACSM Conference in Ft. Worth, Texas.

Bruce has promoted registration and licensure in his community through numerous presentations to business and professional organizations regarding legislative statutes. He is involved in the Oklahoma Society of Land Surveyors, where he served as President, and the National Society of Professional Surveyors.

Bill Dickerson, P.E., Principal Assistant to the Board was presented the Meritorious Service Award. This award was created to recognize Member Board and NCEES employees for outstanding service. Bill was also awarded the NCEES Southern

Zone Meritorious Service Award in April of 1999.

Bill served for five years as a Board Member of the Oklahoma Board. He has been employed as the Principal Assistant for 11 years. In addition to reviewing applications and making recommendations regarding acceptable education and experience, proctoring and coordinating examinations at universities, he has improved examination accommodations markedly as well as improved examination security at the universities for the FE examination.

During his service to the Oklahoma Board, Bill was actively involved in the NCEES and is currently an NCEES Emeritus Member. He participated in various NCEES committees, including the Records Verification Committee, Communications and Publications, where he served as chair; the Committee on Examinations for PE's (Fundamentals), where he serves as subcommittee chair; and the Computer-Based Testing Oversight Group. Bill also works to promote registration and licensure by being the principal speaker at meetings of universities and technical societies.

License Expirations June 1, 2000 to August 31, 2000

EXPIRATION/REVOICATION - Certificates may be revoked by the Board for non-payment of renewal fees. Registrants will be notified of revocation by certified mail.*

RENEWALS - Each registration issued by the Board expires on the last day of the month in which renewal fees are due, and becomes invalid on that date unless paid. One notice of renewal is sent by first class mail to the address of record in the board files.**

REINSTATEMENT - Former registrants whose certificates have expired and were revoked for failure to pay renewal fees and desire to reinstate shall make application for reinstatement within 90 days after expiration and pay the prescribed renewal fee and penalty. After 90 days, a new application will be required, which shall be considered specifically by the Board, both from the standpoint of competency and of character.

*By practice, this notification is mailed 10 days following expiration. **In effect, provides notice two months prior to revocation.

NOTICE: New Law Passed Which May Effect Your License To Practice Engineering and/or Surveying in the State Of Oklahoma

Effective July 1, 2000, Per SB 1040 Sec. 6, all state license holders must be in compliance with state income tax laws prior to having their license renewed. Your name and your firm's name will be furnished to the Oklahoma State Tax Commission prior to your PE

or PLS license, or your certificate of authorization being renewed in Oklahoma. If we are notified that you are in non-compliance with the Oklahoma State Tax Commission, we cannot renew your license until such time as you are in compliance.



In the Matter of Roger Richter, Case No. 2000-31, Summary of Findings of Fact and Order

Roger Richter, a licensed architect, prepared plans for a project and upon completion affixed his signature and architect's seal to the Project plans. Mr. Richter signed and sealed final engineering drawings as part of the Project plans that were not signed or sealed by a registered engineer. Mr. Richter also used a generic foundation system for the project and made engineering decisions affecting the Project's foundation system. Mr. Richter was found guilty of practicing engineering without an engineering registration and ordered to pay an administrative penalty in the sum of \$1,250.00. Mr. Richter was also ordered to cease and desist practicing and offering to practice engineering in the State of Oklahoma.

In the Matter of Schirmer Engineering, Case No. 2000-33, Through Consent

Schirmer Engineering is not authorized to provide engineering services in the state of Oklahoma. Schirmer Engineering provided engineering services in the state without a certificate of authorization and is assessed an administrative penalty in the amount of \$2,000.00. Schirmer Engineering shall cease and desist practicing or offering to practice engineering in the state of Oklahoma until such time as it is authorized to do so. Schirmer Engineering agrees to apply to the Board for a certificate of authorization no later than 10 days following the date of this order and shall cause the appropriate employee of the firm to apply for a certificate of registration with the Board.
