New Online Renewals for Professional Engineers, Professional Land Surveyors & Firms

which enables professional engineers, land surveyors and firms to complete biennial registration renewals and make payment to the Board using the Board's webpage at "www.pels.state.ok.us". The online registration renewal system provides a secure avenue for professional engineers, land surveyors and registered firms to access licensing menus. Through the menu, users can update personal and employment information, change passwords, and renew registrations. Through the individual registration renewal, individuals can report professional development hours to the Board and complete payment online by credit card or electronic funds transfer. Should registrations lapse, individuals and firms may also reinstate within 180 days after expiration. Through the firm registration renewal, firms can report responsible charge professionals and complete payment by credit card or electronic funds transfer.

The Board hopes that this service will assist registrants in expediting the registration renewal process. The best news - there will be no additional fee for renewing your registration online using a credit card or electronic fund transfer. The Board will absord any credit card fees incurred and not pass this expense along to the registrant.

The first group of individuals to receive their registration renewal billings that will allow online renewals are the PE's and LS's whose registration will expire November 30, 2004. Once you have tried the online renewal system, please communicate back to the Board office any suggestions you may have to make this a more user friendly system at "kathy@pels.state.ok.us".

Individuals and firms have been assigned a password/pin number automatically that will be located on the renewal form that is mailed to registrants and registered firms. If you wish to access your personal or employment information prior to the time of your renewal period, you will need to contact this office by e-mailing cindy@pels.state.ok.us and we will send you your password/pin number.

OTHER ONLINE SERVICES AVAILABLE ...

- You may check the registration of an individual or firm go to www.pels.state.ok.us and click on "online roster".
- More information is now available through the online roster, such as renewal dates, whether the firm or individual has ever been disciplined by this Board, and carryover hours for continuing education.
- The firm registration lists individuals in responsible charge and all branch offices.

STATUTE REVISIONS PROPOSED 2004-2005 LEGISLATIVE SESSION Title 59 O.S., Section 475.1 et seq

The Board, with input from professional and technical societies, is reviewing the statutes under its jurisdiction to propose revisions during the 2004-2005 legislative session. The topics under discussion include but are not limited to minor administrative changes, amending the definition of the practice of land surveying, and amending the educational requirements for qualifying to be *registered* as a professional land surveyor.

Even the word *registered* is under debate at this time. Should engineers and land surveyors be *registered* or *licensed*. Currently 18 states and jurisdictions use the term "registered professional" and 35 states and jurisdictions use the term "licensed professional" referring to the professional engineers and land surveyors that hold a registration/license with their Board. The National Council of Examiners of Engineering and Surveying (NCEES) refers to the Boards as "Licensing Boards" and the Model Law refers to "licensed professionals". Some states use the terminology interchangeably.

An open meeting will be held on Friday, November 19, 2004, at 9:00 am at the Oklahoma Engineering Center, 201 N.E. 27th St., Oklahoma City, OK to finalize the draft of statute revisions that will go to the legislature. The draft will be available on our website the first week of November – or you may request a hardcopy of the draft by contacting the Board Office.

License Expirations July 1, 2004 to September 30, 2004

EXPIRATION/REVOCATION - Registrations may be revoked by the Board for non-payment of renewal fees. Registrants will be notified of revocation by certified mail. Typically this notification is mailed 10 days following expiration.

RENEWALS - Each registration issued by the Board expires on the last day of the month in which renewal fees are due, and becomes invalid on that date unless paid. One notice of the renewal is sent by first class mail to the address of record in the board files. This in effect provides notice two months prior to revocation. **REINSTATEMENT** - Former registrants whose certificates have expired and were revoked for failure to pay renewal fees and desire to reinstate shall make application for reinstatement within 180 days after expiration and pay the prescribed renewal fee and penalty. After 180 days, a new application will be required, which shall be considered specifically by the Board, both from the standpoint of connectency and of character.

CORNER RECORD FORM AND INSTRUCTION MANUAL AMENDED

On October 1, 1978, the Corner Perpetuation & Filing Act, Title 65 O.S. 3.116-3.123 became law in Oklahoma. As you know, this law generally requires that professional land surveyors file a corner record form every time a corner established by the original government surveyors is used for control. The success of this law can be measured by the fact that to date over 80,000 such corner records have been filed with the Oklahoma State Department of Libraries-Archives Division.

A great deal of credit for the success of this law can be given to those professional land surveyors who drafted the original corner form and the accompanying instruction manual. These documents were so well constructed that they have remained unchanged since 1978.

Earlier this year, the Oklahoma Society of Land Surveyors (OSLS) appointed a committee to review these 1978 documents. The committee's charge was to determine if those documents needed to be revised to reflect new surveying technology and changing surveying procedures. That committee reported to the general membership of OSLS who approved the changes and requested that the State Board of Registration adopt those changes. The two significant changes are located under the Monument Description and Oklahoma State Plane Coordinates sections. In each of those sections, more information is now required.

The manual of instructions always required that evidence found and supporting evidence be noted in the Monument Description portion of the CCR form. However, over the past few years, some of the CCRs have been deficient in this respect. Thanks to GPS, more and more land surveyors are including state plane coordinates on the CCR form. More specific information about how coordinates

were obtained will enable following surveys to use the points with more confidence.

At the July Board meeting, the Board approved the recommendations of OSLS for revisions to the Certified Corner Record (CCR) Form and Manual of Instructions. A reduced sized copy of the revised CCR form is printed in its entirety on the following page.

Use of the new CCR form is optional until January 1, 2005. After that date, all CCR's must be on this form or they will not be accepted by the Oklahoma Department of Libraries Archives Division.

The Board will send a letter to every Oklahoma registered professional land surveyor explaining the new CCR form and providing copies of the form and instruction manual.

50th Issue of *The Board's Bulletin*

he 1st issue of the Board's Bulletin was published in the Fall of 1987. Upon a review of the 50 newsletters, 50 accomplishments are highlighted that would best define the past 17 years of the Board's work. Many of these accomplishments involve the volunteer efforts of the Board Members and their terms of office - years of their lives that were dedicated (and some still currently dedicating) to serving the profession, the registrants and the citizens of the state of Oklahoma. Listed are accomplishments that were outside the scope of the everday activity of the Board, such as processing application, administering examinations, registering individuals and firms, and hearing disciplinary activity when necessary. That would be far too great a task to undertake.

50 accomplishments, (changes, events, occurences) . . . call them what you wish, but they represent the history of the Board and of the professions, and it is important for us to stop occassionally and look back at where we have been, how far we have come, and to look ahead to where we are going. These are the accomplishments that move the professions forward and help the Board grow to be a better Board.

DIRECTOR OF ENFORCEMENT CONTRACTED BY THE BOARD

he Board recently contracted with Bruce A. Pitts, PLS, to serve as Director of Enforcement Activities. Mr. Pitts is an emeritus member of the Board, serving as a member of the Board from 1991-2000 and serving as Chairman of the Board for two terms. Bruce received a B.S. Degree in Engineering Technology from Oklahoma State University and has been on the land surveying faculty of Oklahoma State University - Oklahoma City since 1979, where he is currently an Adjunct Associate Professor. Mr. Pitts is the past president of the OSLS, and an associate member of the Oklahoma Land Title Association. Mr. Pitts was an Associate with Smith-Roberts and Associates from 1988 to 2004. He has practiced land surveying with emphasis on land title surveys, resolution of boundary disputes and expert testimony since 1976.

During his 9 years as a member of the Board, Bruce worked on the National Council of Examiners for Engineering and Technology (NCEES) Land Surveying Examination Committee. Mr. Pitts also has been instrumental as a member of the OLS Examination Committee since its inception. As a Board Member, Mr. Pitts was very active in the disciplinary activities of the Board, and assisted in developing the current procedures that the Board uses today to process, investigate, and prosecute disciplinary cases. From 2001-2004, Mr. Pitts voluntarily worked with the enforcement committee of the Board in an advisory capacity, contributing his experience as a past Board Member, an educator, and a land surveyor in private practice.

The Board looks forward to working with Mr. Pitts to expedite the handling of the ever-growing case load of complaints and investigations under this Board's jurisdiction.

Reporting Continuing Education for Professional Engineers

Professional Engineers in Oklahoma began reporting their continuing education requirements to the Board for the first time with the July 31, 2004 renewals. The following are a few reminders for those of you who are waiting to report your continuing education credits for the first time:

- ♦ Continuing education obtained by a registrant should maintain, improve or expand skills and knowledge obtained prior to initial registration or to develop new and relevant skills and knowledge." [Board Rules 245:15-11-3(a)]
- ♦ Continuing education must be relevant to the practice of engineering and/or land surveying as applicable and may include technical, ethical or managerial content. [Board Rules 245:15-11-5(b)]
- ♦ The Board does not pre-approve sponsors or courses and you must refer to the criteria listed in the Board rules to ensure that your activity meets the continuing education criteria. [Board Rules 245:15-11-6]
- ♦ You may go back as far as January 1, 2002 to claim continuing education credit the first renewal that you are required to report following July 31, 2004. (assuming you were registered at that time you may not go farther back than the date you were first registered) [Board Rules 245:15-11-5(c)]
- ♦ If you choose to renew online, you may enter your continuing education credit at the time you renew your registration online. If you renew by mail, you must sign your log form and any attachments. [Board Rules 245:15-11-10]
- ♦ The continuing education rules and forms are all located on our website at 'www.pels.state.ok.us'. Go to our website and select "Administration" and at the top of the next page select "Cont. Ed.".
- ♦ The requirement is 30 PDH's per renewal period. DO NOT send in your form and renewal if you have less than 30 hours on your form. It will be returned to you and you will not be able to renew your registration. [Board Rules 245:15-11-5]
- ♦ Do not send in supporting documentation with your renewal and log form. If you are audited you will need to produce these documents, but do not send them to us with your renewal or they will be returned to you. [Board Rules 245:15-11-9]
- ◆ If applicable, remember to claim your 1 PDH for 3 hours of documented self-study. [Board Rules 245:15-11-5(a)(9)]
