This year marks a milestone in the engineering and surveying profession as we celebrate 100 years of engineering licensure in the United States. In 1907, the first engineering licensure law was signed into effect by the Wyoming Legislature, setting a precedent for the engineering licensing boards that now exist in all states, the four U.S. territories, and the District of Columbia. Today, these boards form the National Council of Examiners for Engineering and Surveying (NCEES), a nonprofit organization that provides leadership for the professions of engineering and surveying by creating and maintaining uniform laws, licensing standards, and professional ethics as well as developing, producing, and scoring the only national engineering and surveying licensure examinations.

Jon Nelson was originally appointed to the Board on June 29, 1995 to serve a six year term. He was honored by being reappointed by Governor Henry to serve an additional term from June 29, 2001 to June 28, 2007. During his second term as a Board Member he served as the President of the NCEES in 2004-2005, representing this Board and the state of Oklahoma in a most distinguished manner. Mr. Nelson also served as Board Chair from 2000-2001 and 2006-2007.

Jon D. Nelson, P.E. is being honored by receiving a message commemorating his contributions to engineering and surveying licensure, both locally and nationally, during this special time in our nation s history and in conjunction with Oklahoma's Centennial Celebration. July 12, 2007 is proclaimed *Jon D. Nelson, P.E. – Engineering and Surveying Licensure Day* to officially recognize a century of engineering licensure; the importance of licensure in the engineering and surveying professions in the state of Oklahoma; and Jon D. Nelson, an Oklahoman who has made countless statewide and national contributions to engineering and surveying licensure.

The Board of Architects, Landscape Architects & Interior Designers has a great deal of activity going on this summer! To get things going, the Board has new Rules that were made effective May 11th, along with two changes that were made to the Architectural and Interior Designers Act through SB 60. The new Rules and changes to the Act are in the process of being printed and will be distributed shortly. For a look at the specific legislation, SB 60 can be found at the Oklahoma Legislature's website http://www.lsb.state.ok.us/.

We are also in the middle of the biennial renewals for all Architects, Landscape Architects and their firms as they are all due by June 30th. If you know of any individual or firm who has not received a renewal application at this point in time, it is imperative that they contact the Board office to avoid cancellation. During renewal, we are aware of the fact that military deployment continues to affect the lives of many of our professionals. In order to honor this sacrificed service, the Board is pleased to announce that the new Rules provide that all fees, penalties and continuing education, if applicable, will be waived during the time Licensees, Registrants or Candidates are called to active military duty and deployed to a temporary military assignment.

One last note, Interior Designer registration is well underway! Registration applications are available under the "Forms" section of our website www.ok.gov/interiordesigners.. In order to avoid the rush, the Board is accepting these applications as they can be effective as early as July 1, 2007. It is important to remember that Architects will be grandfathered in as Interior Designers, but only for a short period of time. To take advantage of this opportunity, an active Architect may submit an application for Certificate of Registration between July 1, 2007 and June 30, 2009. Formal registration and application requirements will be required following this two-year window.

The Board of Professional Engineers and Land Surveyors also passed new regulations this year that went into effect May 11, 2007. Most relevant to architects is the Board's new rules OAC 245:15-17-2(h) and (i). Section (h) specifies what process an engineer must go through if a successor licensee takes over a project if the original licensee is incapacitated or deceased. Section (i) specifies the procedure for signing and sealing prototypical plans - including site adaptation of new structures and site adaptations of existing structures. License Expirations January 1, 2007 to March 31, 2007

EXPIRATION/REVOCATION - Licenses may be revoked by the Board for non-payment of renewal fees. Licensees will be notified of revocation by certified mail. Typically this notification is mailed 10 days following expiration.

RENEWALS - Each license issued by the Board expires on the last day of the month in which renewal fees are due, and becomes invalid on that date unless paid. One notice of the renewal is sent by first class mail to the address of record in the board files. This in effect provides notice two months prior to revocation.

REINSTATEMENT - Former licensees whose certificates have expired and were revoked for failure to pay renewal fees and desire to reinstate shall make application for reinstatement within 180 days after expiration and pay the prescribed renewal fee and penalty. After 180 days, a new application will be required, which shall be considered specifically by the Board, both from the standpoint of competency and of character.

ALONG THE PATH TO COMPLIANCE

New Statutes and Rules in Effect

This office receives a significant number of calls from licensees and from the public with all kinds of questions about the laws and rules regulating the practice of engineering and land surveying. We welcome citizen calls and look upon them as an opportunity to educate the public about the professions we regulate. Matters like the signing and sealing of documents, what constitutes a violation, and what exactly is the definition of engineering and land surveying are all subjects that garner phone calls from licensees. And since keeping up with the statutes and rules is required of all licensees, we strive to keep the current information readily available.

Keeping current is very important as a professional. The legislature just revised the rules governing the practice of engineering and land surveying, and in response to the legislative action the Board published a 106 page new statute and rules book containing the most current revisions to statute and rules regulating the practice of engineering and land surveying. The new rules became effective on May 11, 2007 and will govern the practice from that date. These laws and rules are available on our website: pels.state.ok.us or can be mailed to you upon request.

The new rules contain updated language in the Minimum Standards for the Practice of Land Surveying. Surveyors should familiarize themselves with these standards immediately as they were effective as of May 11, 2007.

A new section of the rules was drafted that deals with the role of the successor engineer that, coincidentally, is one of topics about which we receive several inquiries and also one where we have several enforcement cases. The statutes and rules do not allow a P.E. to sign and seal plans prepared by an architect, contractor or anyone else unless that person was under the direct control and personal supervision of the P.E. For example, an architect cannot prepare the plans for a project and then bring the engineering parts of those plans to an engineer for review, signature and seal. The new rules do allow for a P.E. to take responsible charge over a *standard*, *prototypical design plan* for adapting the plan to a specific site in this state. The licensee in this case must have complete responsible charge over all professional engineering services to include development of a complete design file including work of design criteria, calculations, code research, and any necessary and appropriate changes to the work. The burden in such cases will be on the successor licensee to demonstrate such compliance.

The specific rules for signing and sealing of all engineering and land surveying documents can be found in Section 245: 15-17-2 of the new rules. Chris Stewart is found Guilty of aiding and assisting Chris Stewart Surveying in the unauthorized practice of land surveying; failing to sign or seal or otherwise state on a drawing that the drawing was preliminary; failing to file multiple corners; aiding and assisting L & L Surveying, Inc. in the unauthorized practice of land surveying; and signing

a survey for which he was not in responsible charge. He is hereby Reprimanded and assessed administrative penalties in the sum of \$4,250. Mr. Stewart will file all corner records as set forth in the order within sixty days from the order and submit proof to the board. Further, for a period of one year Mr. Stewart will submit a copy to this board of each survey in which a Public Land Corner is used for control of the survey. He will furnish copies of all Certified Corner Records used or filed for those surveys to the Board.

In the Matter of Mark T. Gay, PLS 1354 and Red Plains Surveying Company, CA 3948; Case No. 2006-93; Through Consent: For failing to exercise prudent and deliberate consideration in developing a survey for a final plat and failing to perform responsible and thorough investigation and research in preparing the survey, Red Plains Surveying Company is found Guilty of Gross Negligence, Reprimanded and assessed an administrative penalty of \$2,500. For failing to exercise prudent and deliberate consideration in developing a survey for a final plat and failing to perform responsible and thorough investigation and research in preparing the survey, Mark T. Gay is found Guilty of Gross Negligence, Reprimanded and assessed an administrative penalty of \$2,500.

In the Matter of Albert Hermans, PE 22437; Case No. 2006-98; Through Consent: For offering and practicing engineering in the state of Oklahoma without a certificate of licensure to do so; for aiding and assisting Energy Engineering, Inc. in the unauthorized practice of engineering; and for signing and sealing plans that were not prepared under his direct supervision or control; Mr. Hermans is found Guilty, Reprimanded, and assessed administrative penalties in the sum of \$3,000.

In the Matter of Artic Temp, Inc.; Case No. 2007-01; Through Consent: For offering and practicing engineering in the state of Oklahoma without a certificate of authorization to do so, Artic Temp, Inc. is found Guilty, ordered to Cease and desist from the practice or offering to practice engineering in the State of Oklahoma until such time as it has been authorized to do so, and assessed an administrative penalty in the amount of \$3,000.

In the Matter of Bill Phillips and AAI Air Conditioning & Heating; Case No. 2007-05; Through Consent: For offering and practicing engineering in the state of Oklahoma without a certificate of authorization to do so, AAI Air Conditioning & Heating is found Guilty, ordered to Cease and Desist from the practice or offering to practice engineering in the state of Oklahoma until such time as it has been authorized to do so, and assessed an administrative penalty in the amount of \$500. For offering and practicing engineering in the state of Oklahoma without a certificate of licensure to do so, Bill Phillips is found Guilty, ordered to Cease and Desist from the practice or offering to practice engineering in the state of Oklahoma until such time as he has been authorized to do so, and assessed an administrative penalty in the amount of \$500.

In the Matter of Elbert Alexander and Alexander Plumbing & Heating; Case No. 2007-06; Through Consent: For offering and practicing engineering in the state of Oklahoma without a certificate of authorization to do so, Alexander Plumbing & Heating is found Guilty, ordered to Cease and Desist from the practice or offering to practice engineering in the state of Oklahoma until such time as it has been authorized to do so, and assessed an administrative penalty in the amount of \$500. For offering and practicing engineering in the state of Oklahoma without a certificate of licensure to do so, Elbert Alexander is found Guilty, ordered to Cease and Desist from the practice or offering to practice engineering in the state of Oklahoma until such time as he has been authorized to do so, and assessed an administrative penalty in the amount of \$500.

In the Matter of Vanco Engineering Co.; Case No. 2007-20; Summary of Findings of Fact and Order: For offering and practicing engineering in the state of Oklahoma without a certificate of authorization to do so, Vanco Engineering Co. is found Guilty, ordered to Cease and Desist from using the word Engineering in the name of the firm until such time as it has a licensed Professional Engineer in responsible charge of the engineering activities of the firm, and assessed an administrative penalty in the amount of \$500.

In the Matter of L & L Surveys, Inc., CA 4609; Case No. 2007-32; Through Consent: For offering and practicing surveying in the state of Oklahoma without a certificate of authorization to do so, L & L Surveys, Inc. is found Guilty, ordered to Cease and Desist from the practice or offering to practice land surveying in the state of Oklahoma until such time as it has been authorized to do so, and assessed an administrative penalty in the amount of \$500.

Association of Engineering Societies Chooses Jon Nelson as Chair-Elect

A t its most recent meeting, the American Association of Engineering Societies (AAES) elected Jon Nelson, P.E., NCEES [National Council of Examiners for Engineering and Surveying] president in 2004-2005, as chair-elect. The unanimous vote reflects the renewed connection between NCEES and AAES.

NCEES rejoined AAES in February 2006, six years after withdrawing its membership. As a result of changes in AAES structure and at the urging of other engineering societies, the NCEES Board of Directors has reevaluated and decided it is again beneficial to participate in AAES.

"The purpose of joining AAES is to help create a uniform voice for the engineering profession—one that recognizes the importance of licensure," says NCEES Associate Executive Director Jerry Carter. These organizations want to become more effective by pointing resources in the same direction and avoiding duplicate efforts.

The objective of AAES is to advance the knowledge and practice of engineering by providing a forum for engineering societies to discuss shared goals and to collaborate to accomplish them. One goal that many of the 12 member organizations share is promoting engineering among children and teens.

The Council's efforts in this area have included major sponsorship of *Design Squad* [a new reality-based PBS television series for preteens to get students to engage critical-thinking skills while illuminating the design process (see pbskids.org/designsquad)] and annual participation in National Engineers Week and the Future City Competition that accompanies it. To evaluate the benefits of greater collaboration in these and similar efforts, NCEES has joined an AAES study group focused on K-12 programs.

Through this group, NCEES contributed to the development of five chapters of K-12 engineering educational standards. These draft standards, produced by the American Society of Engineering Education, provide a framework for curriculum developers as they integrate information about engineering into K-12 programs, increasing all students understanding of the engineering profession.

As NCEES representative to AAES since 2005, Nelson has presented the Council's activities to the other members and discussed strategies for AAES members to work together and focus their efforts. Now, as AAES president-elect, he continues to promote cooperation.

"The organization is ready to go forward," says Nelson. "And I believe it will serve its purpose in uniting the profession – something that is truly needed."
