Also, the Board is busy with education requirements for surveyors as they are increasing to two or four year degrees, with a mixture of educational core classes and experience. State Boards across the nation also continue to debate the education requirement for engineers – 4 year BS degree, BS degree + Masters, 150 hours, etc. I think the only consensus is that this item needs further discussion.

From the Board of Governors of Architects, Landscape Architects, and Interior Designers

The Board of Licensure for Professional Engineers and Land Surveyors

The Joint Practice Committee, consisting of members and staff from the Board of Governors of Architects, Landscape Architects, and Interior Designers and the Board of Licensure for Professional Engineers and Land Surveyors continues to meet, share information, and work towards resolving conflicts and improving communications between the Boards and the professions. The Committee is planning to hold a joint meeting with Building Code Officials and other interested parties in the next few months.

The Enforcement Division of both Boards have begun meeting together, exchanging case information and sharing their enforcement resources. Both Boards are optimistic that this will improve the enforcement and regulation of all professions involved and will better serve to protect the health, safety, and welfare of the public.

Message from the Chair - (cont.)

Last year we went through several changes to the Board Statute. One of the changes was to establish a tier of education and experience for surveyors. Another change was to establish the capability of electronic signatures. We are now working on Board Rule changes that would set the conditions for electronic signatures. Another item that is being revised is the "presence in the workplace" statement in the definition of direct control and personal supervision. Both of these items are critical in allowing the licensees to work in the Twenty-First Century. The Board works hard to keep the Statute and Rules current to meet the needs of today's professions. Most importantly, our focus is to look out for the safety and protection of the public. The Board will hold a Public Hearing on Friday, November 14th at 2:00 p.m. for your input to the Board Rule changes. Please check the web site for a draft of these changes.

Other topics that are on the Board's agenda for this year are:

Foundation Repair Companies, Home Inspection Examiners, Engineer and Architectural roles and duties, Continuing Education, Plan Examiners and Building Officials.

Ross Relph, P.E., P.L.S. Leaves His Mark on the Board



Former Board Member Ross Relph, P.E., P.L.S., passed away on July 2, 2008. Mr. Relph served on the Board from July 2000 to June of 2002. He was appointed by former Governor Frank Keating to fill the remaining term of Bob Cornforth, P.E., who passed away while he was serving as a Board Member.

Mr. Relph was a partner in the consulting firm of Lowrie & Relph Engineering Company in Oklahoma City from 1960 to 1985. In 1988 he formed a private engineering firm, focusing on foundation reports, soils evaluations, damage reports covering fire and storm losses, and structural analyses of commercial buildings and ancillary equipment. Mr. Relph was instrumental in continuing the work that Mr. Cornforth had started on the Board with Building Code Officials and to publish the A/E Brochure.

COMPLIANCE GUIDELINES FOR FOUNDATION REPAIRS RESCINDED

As previously reported, *the Compliance Guidelines for Foundation Repairs* adopted by the Board were rescinded. The Oklahoma Structural Engineers Association (OSEA) is exploring other avenues to protect the public regarding foundation repairs. A committee has been formed to review the Guidelines and to determine what, if anything, can be done concerning improper, inadequate, and unethical foundation repairs that are performed in Oklahoma.

License Expirations April 1, 2008 to June 30, 2008

EXPIRATION/REVOCATION - Licenses may be revoked by the Board for non-payment of renewal fees. Licensees will be notified of revocation by certified mail. Typically this notification is mailed 10 days following expiration.

RENEWALS - Each license issued by the Board expires on the last day of the month in which renewal fees are due, and becomes invalid on that date unless paid. One notice of the renewal is sent by first class mail to the address of record in the board files. This in effect provides notice two months prior to revocation.

REINSTATEMENT - Former licensees whose certificates have expired and were revoked for failure to pay renewal fees and desire to reinstate shall make application for reinstatement within 180 days after expiration and pay the prescribed renewal fee and penalty. After 180 days, a new application will be required, which shall be considered specifically by the Board, both from the standpoint of competency and of character.

USE OF ONLINE RENEWAL SYSTEM AT AN ALL-TIME HIGH

Piscal year 2008 proved to be a record-breaking year for the Board's online renewal system. For the first time, online renewals topped 50% of total renewals. We encourage you to continue using the system and, if you haven't used the system, please give it a try.

Helpful Features of the Online Renewal System:

- Ability to keep track of your continuing education as you go;
- Cuts down on the ever-rising postage costs;
- Convenient way to update address changes and other personal contact information;

Different than in the past, instead of receiving a full renewal packet from the Board 60 days prior to their expiration date, licensees will receive a notice that its time to go online and renew their license. Disciplinary Activity of the Board

July 17 & 18, 2008

In the Matter of Carl Wayne Willyard, P.L.S. 227; Case No. 2007-029; Final Order on Show Cause; Carl Wayne Willyard is ordered to continue the probation ordered on July 12, 2007 for an additional six (6) months. During the probation period, he must take and pass the Oklahoma Law and Surveying Examination, provide satisfactory evidence of required corner filings on past surveys, and provide evidence of the review and evidence of approval by the reviewing surveyor of all surveys done in the past year to indicate compliance with the July 12, 2007 order. Also he must provide evidence of the review and approval of all surveys by the reviewing surveyor during the probationary period.

In the Matter of Edwards and Kelcey, Inc., Case No. 2007-101; Through Consent; for offering to practice engineering in the State of Oklahoma without a Certificate of Authorization to do so, Edwards and Kelcey, Inc. is found Guilty, assessed an administrative fine of \$1,000.00, and ordered to Cease and Desist from practicing and/or offering to practice engineering in the State of Oklahoma until such time as it has been issued a Certificate of Authorization in accordance with the laws of the State of Oklahoma.

In the Matter of Robert Lee Williamson, TP 706 (revoked), Case No. 2008-021; Through Consent; for failure to have made application for licensure within thirty (30) days of the date of his Temporary Permit Application and for failure within thirty (30) days to provide information requested by the Board as a result of a formal or informal complaint, Robert Lee Williamson is found Guilty, assessed an administrative fine of \$1,000.00, and ordered to Cease and Desist from practicing and/or offering to practice engineering in the State of Oklahoma until such time as he has been issued a Certificate of Licensure in accordance with the laws of the State of Oklahoma.

Moore, P.E. 6077, Case No. 2008-022; Through Consent; for signing and sealing engineering plans not prepared under his direct control and personal supervision; for his undertaking the project when he was not qualified by education or experience in mechanical and plumbing; and signing and sealing documents dealing with subject matter in which he lacked competence; Richard L. Moore is found **Guilty**, assessed an administrative fine of \$1,000.00 and is hereby **Reprimanded**.

In the Matter of EMC Engineers, CA 5435 and Melvin G. Glass, P.E. 23331, Case No. 2008-037; Through Consent; for offering and practicing engineering in the State of Oklahoma without a Certificate of Authorization to do so, EMC Engineers is found Guilty, assessed an administrative fine of \$1,000.00 and is hereby Reprimanded. For aiding and assisting EMC Engineers in offering and practicing engineering in the State of Oklahoma without a Certificate of Authorization to do so and for offering and practicing engineering in the State of Oklahoma without a Temporary Permit or a Certificate of Licensure to do so, Melvin G. Glass is found Guilty, assessed an administrative fine of \$2,000.00 and is hereby Reprimanded.

Moore is found **Guilty** and HIS P.E. License No. 18951 is hereby **REVOKED**.

September 4 & 5, 2008

In the Matter of Wm. Alan Brooks, P.L.S. 1593 and Brooks Surveying and Mapping, Inc., CA 4450; Case No. 2007-081; Through Consent; for violation of the Oklahoma Minimum Standards for the Practice of Land Surveying, Brooks Surveying and Mapping, Inc. is found Guilty and is hereby Reprimanded. Nigus is found Guilty, assessed an administrative fine of \$500. and ordered to Cease and Desist from offering and/or practicing engineering in the State of Oklahoma until such time as he has been issued a Certificate of Licensure in accordance with the laws of the State of Oklahoma.

In the Matter of Zinser Grossman Structural, L.L.C., CA 5478 and Richard A. Zinser, Jr., P.E. 19288; Case No. 2008-059; Through Consent; for offering and practicing engineering in the State of Oklahoma without a Certificate of Authorization to do so, Zinser Grossman Structural, L.L.C. is found Guilty, assessed an administrative penalty of \$500 and is hereby Reprimanded. For aiding and assisting Zinser Grossman Structural, L.L.C. in offering and practicing engineering in the State of Oklahoma without a Certificate of Authorization to do so, Richard A. Zinser is found Guilty, assessed an administrative fine of \$500 and is hereby Reprimanded.

In the Matter of Brandon D. Storm, P.E. 20482; Case No. 2008-060; Through Consent; for signing and sealing engineering plans not prepared by him or under his direct control and personal supervision, Brandon D. Storm is found **Guilty**, assessed an administrative penalty of \$2,500.00 and is hereby **Reprimanded**.

The Path to Compliance

Proposed Rule Changes to Effect Enforcement

Each time the language of the licensing statute (Title 59 O.S. Section 475.1 et seq.) is amended by the state legislature, the Board begins the Rulemaking process to accompany the statute change. Since the statute was amended effective November 1 of this year, the Board has been engaged in writing rules to be publicly discussed in a Public Meeting at the Board office at 2:00 on November 14th. Many of the proposed changes are meant to clean-up or clarify terms in the statute, and many address specific statutory changes like electronic signatures or surveying education requirements. However, there is one change that will directly affect the issue that is a common subject of complaints: the issue of the definition of direct control and personal supervision a licensee must exert over an engineering or surveying project.

Public protection demands that our licensees, who have successfully demonstrated professional competency by experience, education and examination be in responsible charge of engineering and land surveying projects. Signing and sealing work not done under the direct and control personal supervision of a licensee, or "plan stamping", is a serious violation of the trust the public has placed on our licensees because it is not only a potential threat to the success of the project, but it is also demeaning to the profession. Two distinct and different forms of "plan stamping" exist. One is a much more flagrant violation and that occurs when an engineer or surveyor is asked to put his/her seal on plans that have been completed with a cursory review or no review of the plans. This is an obvious violation.

The less obvious violation is the scenario in which an engineer or surveyor reviews the work of others, and chooses to take the liability for the project without meeting the specifics in the definition of direct control and personal supervision. Part of the reason this type of "plan stamping" exists is that in the past our laws and rules contained provisions that allowed for the licensee to assume direct control and personal supervision over a project by just thoroughly reviewing plans done by others. That law was changed many years ago, but unfortunately the practice continues. Consequently this board has disciplined several licensees who have reviewed and signed and sealed plans prepared by others who were not under their direct control and personal supervision. When asked by this Board, the licensee could not even produce a design file or independent calculations, or answer questions relating to the design criteria, code research, or methods of analysis. In some of the cases before the board, the licensees did not have the authority to make necessary and appropriate changes to the plans they sealed.

The clarification of the definition found in the proposed rules clearly enumerates the requirements that the licensee must exercise to be in direct control and personal supervision of an engineering or surveying project, even though it allows for some "remote" direct control and personal supervision. The board believes that personal presence in the workplace is still necessary; however, in those cases where the licensee can demonstrate the capacity of instant communication and electronic transfer of data between the main office and a branch office, and where the rest of the components of direct control and personal supervision as specified are met, the board's proposed language will allow for some amount of remote direct control and personal supervision.

The proposed rule changes will impact the land surveying and engineering professions in Oklahoma. The proposed revisions have been placed on the board website: www.pels.state.ok.us for review and hopefully comment by interested licensees. Licensee input is welcome both in writing before the open meeting and in person at the 14th of November Public Meeting. As licensees working in different professions, and working in different sectors of the professions, your input is very important to this process, so please review the proposed rule revisions and submit your comments for the Board's consideration.
