All clemency hearings are scheduled for 9 am at Kate Barnard Community Corrections Center.

Mr. Bates reports the Counsel for Richard Glossip request to move his clemency hearing back a few

weeks to allow the post-conviction application that was submitted to go on the Oklahoma Court Appeals to be heard.

Mr. Bates states that August 23<sup>rd</sup>, 2022 is available to reschedule the Glossip hearing. The Board discussed the schedule.

Richard Smothermon states he will recuse from any decisions made for the Glossip hearing.

Cathy Stocker made a motion to move Richard Glossip Clemency date to August 23, 2022, Edward Konieczny seconded. The Board carried the motion 3-0.
