

# PARDON AND PAROLE BOARD Business Meeting Minutes

#### I. Call To Order – Scott Williams - Chairman

#### B. Assurance of Compliance with Open Meeting Act

# 3. Legal Updates

General Counsel Kyle Counts gave a brief update on revocations, 31 revocations total were sent over to the Governor's office. Additionally, an update on commutations. The old applications will be mixed in with the newer applications on the upcoming commutation docket. The applicants were given 90 days to respond back with the newer application. After the 90 days the old applications will be docketed as is in the order they were received. After docketing the old applications that were complete prior to May 2022, the Pardon and Parole Board will only be docketing with the new application form.

Executive Director Tom Bates thanks the Pardon and Parole staff members for all their work, Mr. Bates hopes to add additional staff members with the budget increase.

Dr. David McLeod presented information regarding Annual Reports. Richard Smothermon made a motion to approve the Pardon and Parole Board Annual Reports, Larry Morris seconded. The Board carried the motion 4-0.

#### IV. Training and Presentation from Project Commutation – Glen Blake, Executive Director;

Stephanie Horten, Deputy Director; Morgan Hale, Parole Attorney; Madison Boone, Parole Attorney; Shannon Brown, Legal Reentry Attorney; Kelly Austin, Reentry Supervisor Project Commutation presented a summary of services and resources they provide and fielded questions from the Board members.

# V. Discussion and Possible Action on Scheduling of Clemency Hearing for Richard Glossip – Tom Bates

Dir. Bates stated the Richard Glossip clemency hearing was scheduled August 23, 2022, but was stricken due to the Governor granting a 60-day stay to allow the Court of Criminal Appeals to review the pending application for post-conviction relief. The new execution date is scheduled for December 8<sup>th</sup>, 2022. The Board discussed potential dates for the clemency hearing but did not announce one at the time of the meeting. The Board confirmed that one would be selected and announced as soon as possible.

Tom Hird, attorney representing Benjamin Cole, requested rescheduling Cole's clemency hearing for a later date following a pending hearing on competency. The Board denied the request and left the clemency hearing scheduled for September 27.
