**XVII. Call to Order – Chairman Scott Williams-**

Attorneys Tricia Russell and Emma Rolls joined by paralegal Kim Ludwig and Dr. Barry Crown, presented on behalf of Mr. Fairchild for 35 minutes, having reserved five minutes for rebuttal.

Assistant Attorneys General Jennifer Crabb and Julie Pittman presented to the Board in opposition to clemency for Mr. Richard Fairchild.

The meeting recessed at 10:23 a.m. and reconvened at 10:30 a.m.

After the recess Michael Hurst presented to the Board as the victim representative on behalf of victim Adam Broomhall, in opposition to clemency for Mr. Richard Fairchild.

Attorneys Tricia Russell and Emma Rolls, legal representative for Richard Fairchild, provided a five-minute rebuttal.

Richard Fairchild elected not to appear before the Board.

The meeting recessed at 10:41 a.m. and reconvened at 10:50 a.m.

Chairman Scott Williams called for a vote on clemency for Richard Fairchild, and the vote was 1-4. The clemency recommendation was denied.

The final action of the Board was to not make a recommendation for clemency for Richard Stephen Fairchild.


**XIX. New Business Not Known or Which Could Not Have Been Reasonably Foreseen Before the Posting of the Agenda.**
