CHAPTER 10. LICENSURE OF PSYCHOLOGISTS**

- 575:10-1-7 Hiring of psychological technicians by psychologists [AMENDED]

**SUMMARY:**

The proposed rule changes, if approved, will (1) eliminate unnecessary language and clarify the documents required for documentation of the doctoral program (OAC 575:10-1-2(f)); (2) provide consistence language for all doctoral programs (OAC 575:10-1-2(f)(1)); (3) remove unnecessary language regarding supervision and outline the predoctoral internship requirements (OAC 575:10-1-2(h)(i)(j)(k)); (4) remove unnecessary language and provides the option for hybrid supervision (OAC 575:10-1-2(k)); remove unnecessary language and outline the requirements for the postdoctoral experience (OAC 575:10-1-2(k)); (5) update the language and process for practice under supervision agreements (OAC 575:10-1-3(c)); (6) update the process and requirements for reinstatement of an Inactive or Invalid license (OAC 575:10-1-5(b)(2)(3)); (7) provide a guidance for a name change (OAC 575:10-1-5(d)); (8) make the language regarding the application for psychological technicians more concise and reference another rule regarding the application fee (OAC 575:10-1-7(a)(1)(3)); (9) allow psychological technicians to have a business card in a board approved format (OAC 575:10-1-7(f)); (10) give the chairperson or vice chairperson the authorization to approve requests for relief for previous years continuing professional education requirements (OAC 575:10-1-8(l)); and (11) set a limit for which the psychological technician fee and renewal fee can't exceed (OAC 575:10-1-9(b)).

**AUTHORITY:**

The State Board of Examiners of Psychologists has the authority to promulgate Rules for this area of control according to Title 59, O.S. 1981, Section 1352.1(8).
