## **Medicare Eligible Members**

Representatives from the Medicare Advantage Prescription Drug Plans (MA-PD) will attend the meetings held within their service areas. If you will become eligible for Medicare on or before January 1, 2011, you should plan to attend one of the meetings for Medicare eligible members.

## **Pre-Medicare Members**

Pre-Medicare meetings are scheduled for members who are under age 65 and not currently eligible for Medicare. All of these meetings are set to begin at 1:30 p.m.
