## BOARD OF LICENSED SOCIAL WORKERS MEETING MINUTES

## Meeting called to Order with Role Call at 4:00pm

Discussion and possible action: Changes to the supervisor attestation document approved for LCSW supervisors at the Board Meeting held on July 10<sup>th</sup>, 2015.

Marks presented an overview of the changes to the document approved at the meeting held on July 10<sup>th</sup>, 2015. After review and discussion, Board Member Schlittler made a motion to approve the changes to the LCSW Supervisor Attestation Document. Seconded by Board Member Wallace. Vote was unanimous in the affirmative.

Discussion and possible action: Non-licensed practitioners whose contracts with the Oklahoma Healthcare Authority have been terminated. Subject matter will include discussion of post provisional clinical supervision by individuals holding a mental health related professional license other than a clinical social work license.

As requested at the July 10<sup>th</sup>, 2015 Board Meeting, Board Counsel Kramer presented to the Board of Directors an opinion as to whether the Board of Directors had the legal authority to approve clinical supervision of individuals post their provisional year of clinical licensure with an individual holding a mental health license other than the LCSW. Board Counsel Kramer informed the Board that since there are no laws or rules addressing supervision after application approval of the provisional license, there is nothing in the statutes and rules of the Board prohibiting the Board of Directors from making the determination that supervision provided by another licensed mental health professional would be equivalent to supervision by a person who meets the qualifications for a BAS for purposes of supervision that occurs after the application

approval and the one year of provisional licensure. After discussion among Board Members, Board Member Wallace made the motion that the Oklahoma State Board of Licensed Social Workers accept post provisional license clinical supervision from individuals who hold a professional mental health license other than Social Work. Because of the statutory changes that went into effect November 1<sup>st</sup>, 2014, this motion would reflect clinical supervision received before that date. Seconded by Board Member Schlittler. Vote was unanimous and in the affirmative.
