1. Mr. Hampton secures formal board approved supervision with an approved supervisor as identified by the Board of Social Work should he gain employment during the approval year of this provisional license.
2. As a condition of that supervision, Mr. Hampton must submit a minimum of two evaluations to the Board Office at six month mark of employment and the end of the approval year. The Board Office may request additional evaluations should problems be identified during the period of supervision.
3. Mr. Hampton must complete a three (3) hour Ethics workshop with an emphasis on boundary violations by November 1st, 2020. The ethics workshop may be completed online or in person and must be with an approved provider through the Oklahoma Social Work Board, NASW, or ASWB.

Dr. Rehder seconded the motion. The vote was unanimous in the affirmative.

Discussion and possible action: Consideration for the Licensed Masters Social Work (LMSW) be included among list of qualified Licensed Mental Health Professional qualifications as per 43A O.S. Section 1 -103(11)(f).

After discussion among Board Members the Board determined the LMSW licensed individual should not be added to Title 43 because that level of licensure was not consistent with the licensure levels currently identified in the statute, e.g., LMSWs cannot assess or diagnose independently of a qualified licensed practitioner whereas those identified in the statute can.
