Complete page 1 of the "Oklahoma Use Tax Consumer Report", item numbers 1 through 10 before completing the "supplement".

SPECIFIC INSTRUCTIONS

- ITEM A. - Enter your taxpayer identification number.
- ITEM B. - Enter the month and year for the month of purchases being reported.
- ITEM C. - Enter the date the report is due.
- ITEM D. - Enter your Use Tax Account Number.
- ITEM E. - Provide your name and mailing address.
- ITEM H. - Enter each individual page number and the total number of pages enclosed.

Lines 5 through 24:

- Column I - Print the name of the city or county for which you are remitting tax.
- Column J - Enter the "net taxable purchases" for each city or county.
- Column K - Multiply the amount in Column J by the applicable rate and enter the amount of city/county tax due.
- Column L - If this report and remittance is postmarked after the due date shown in item C, the tax is subject to interest and penalty from the due date until it is paid. Multiply the amount in Column K by the applicable rates for each month or part thereof that the report is late.
- Column M - Total Column K and Column L for each city listed.
- Column N - Enter the code for each city or county for which you are remitting tax.
- ITEM O. - (Total City/County Tax) - Add lines 5 through 24. Enter the total for this page. Include the total of all supplement pages on LINE 11 of page 1.
