ORDINANCE NO. 03-05

**AN ORDINANCE EXTENDING THE CORPORATE LIMITS OF THE CITY OF ADA, OKLAHOMA, ANNEXING AN AREA ADJACENT TO THE CITY OF ADA INTO AND AS A PART OF THE CORPORATE LIMITS OF SAID CITY OF ADA, AS SAID ANNEXATION IS MORE PARTICULARLY DESCRIBED IN THIS ORDINANCE; AND DECLARING AN EMERGENCY.**

**WHEREAS**, a written request has been presented to the City Council of the City of Ada, Oklahoma, signed by the owners of at least a majority of the acres proposed to be annexed, requesting consideration, approval and passage of an ordinance extending and annexing into the corporate limits of the City of Ada certain real property adjacent or contiguous to the city limits of the City of Ada, as provided under the Charter and Ordinances of the City of Ada, and the laws of the State of Oklahoma, and said Council after hearing the facts and being sufficiently advised, is of the opinion that all requirements necessary for the annexation of said property into the City of Ada and to extend the corporate limits thereof have been complied with as provided by the Charter and Ordinances of the City of Ada, and the laws of the State of Oklahoma as set forth in Title 11, Oklahoma Statutes, Section 21-101, *et seq.*

**BE IT ORDAINED BY THE COUNCIL OF THE CITY OF ADA, OKLAHOMA:**

**Section 1.**

That said area shall become attached to and be within the corporate limits of the City of Ada, Oklahoma, and shall hereafter be considered an integral part of the corporate limits, and said corporate limits to the City of Ada, Oklahoma, are extended and enlarged so as to include all of the property described as follows, to-wit:

All that part of the N/2 NW/4 of Section Fourteen (14), Township Three (3) North, Range Six (6) East, Pontotoc County, Oklahoma, lying West of State Highway 99 and North of the platted access road (Stonecipher Boulevard), containing 22.22 acres, more or less; and,

The entire right-of-way of Stonecipher Boulevard, lying West of State Highway 99, in Section Fourteen (14), Township Three (3) North, Range Six (6) East, Pontotoc County, Oklahoma

**Section 2.**

Said property shall retain its current zoning classification of A-2, Suburban District.


**Section 3.**


