

AN ORDINANCE ANNEXING CERTAIN TERRITORY TO THE CITY OF ALVA, WOODS COUNTY, OKLAHOMA; AND DECLARING AN EMERGENCY.

WHEREAS, the owners of the following described lands now owned by them and now adjoining the City of Alva, Oklahoma, having requested from the City Council of the City of Alva, Oklahoma, that said lands be annexed to said City and become a part of the territory included within the corporate limits of said City, and having given their written consent therefor, said lands and premises being described in said request and consent and hereinafter particularly described; and

WHEREAS, it is the opinion of the Mayor and Council of the City of Alva, that said property should be annexed as requested;

NOW, THEREFORE, BE IT ORDAINED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF ALVA, OKLAHOMA:

SECTION ONE: That all of certain pieces and parcels of land now adjoining the City of Alva, and bounded and described as follows, to-wit:

A tract of land lying in the Southwest Quarter (SW/4) of Section Nineteen (19), Township Twenty-seven (27) North, Range Thirteen (13) West of the Indian Meridian, Woods County, Oklahoma, more particularly described as follows: Commencing at the Southwest corner of the SW/4 of said Section 19; thence North 00°09'56" West along the West line of said SW/4 a distance of 918.00 feet; thence North 90°00'00" East and parallel to the South line of said SW/4 a distance of 1216.00 feet; thence South 00°09'56" East and parallel with the West line of said SW/4 a distance of 318.00 feet to the point of beginning; thence North 90°00'00" East and parallel to the South line of said SW/4 a distance of 130.00 feet; thence South 00°09'56" East and parallel with the West line of said SW/4 a distance of 600.00 feet to a point on the South line of said SW/4; thence South 90°00'00" West along the South line of said SW/4 a distance of 130.00 feet; thence North 00°09'56" West and parallel with the West line of said SW/4 a distance of 600.00 feet to the point of beginning.

be and the same are hereby annexed to and shall hereafter be a part of the territory included within the corporate limits of the City of Alva, Woods County, Oklahoma.

SECTION TWO: It being immediately necessary for the preservation of the peace, health and safety of the citizens of the City of Alva, Oklahoma, that this ordinance be passed without delay, an emergency is hereby declared to exist, by reason whereof this ordinance shall take effect and be in full force from and after its passage, approval and publication.


