

ORDINANCE NO. 2008- 13

AN ORDINANCE REPEALING ORDINANCE NO. 2007-12, IN ITS ENTIRETY; AND ANNEXING CERTAIN TERRITORY TO THE CITY OF ALVA, WOODS COUNTY, OKLAHOMA; AND DECLARING AN EMERGENCY.

WHEREAS, the City Council of the City of Alva, Oklahoma, heretofore approved Ordinance No. 2007-12, and pursuant thereto annexed certain territory in and to the City of Alva, Oklahoma; and,

WHEREAS, the legal description of the property annexed by Ordinance No. 2007-12 was erroneous; and,

WHEREAS, the Council of the City of Alva desires to correct the legal description and to annex certain territory to the City of Alva, Woods County, Oklahoma; and,

WHEREAS, it is the opinion of the Mayor and Council of the City of Alva, that the property hereinafter described be annexed.

NOW, THEREFORE, BE IT ORDAINED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF ALVA, OKLAHOMA:

SECTION ONE: Ordinance No. 2007-12 is hereby repealed, in its entirety, and is held to be null and void.

SECTION TWO: That all of certain pieces and parcels of land now adjoining the City of Alva, and bounded and described as follows, to-wit:

The following tracts of land in the Northwest Quarter of the Northeast Quarter (NW/4 NE/4) of Section Twenty-five (25), Township Twenty-seven (27) North, Range Fourteen (14) W.I.M., more particularly described as follows:

Tract 1: Beginning at a point 1,206.00 feet east and 688.62 south of Section of the northwest corner of the Northeast Quarter (NE/4) of said section 25, thence west 75 feet; thence south 75 feet; thence east 75 feet; thence north 75 to the point of beginning; and,

Tract 2: Beginning at a point 207.42 feet south of the Southeast corner of Block Three (3) of the Reid Second Addition. Thence west 75 feet; thence south 75 feet; thence east 75 feet; thence north 75 feet to the point of beginning; and,

Tract 3: Beginning at a point which is 282.42 feet south of the Southeast corner of Block Three (3) of the Reid Second Addition to the City of Alva, thence west Seventy-five feet (75'); thence South One Hundred feet (100'); thence east Seventy-five feet (75'); thence north One Hundred feet (100') to the point of beginning; and,


Tract 4: A One foot (1') strip of land lying adjacent to tracts One (1), Two (2) and Three (3) above and beginning at the Southeast corner of Block Three (3) of the Reid Second Addition to the City of Alva, Oklahoma, thence south 382.42 feet; thence east One foot (1'); thence north 382.42 feet; thence west One foot (1') to the point of beginning;

be and the same are hereby annexed to and shall hereafter be a part of the territory included within the corporate limits of the City of Alva, Woods County, Oklahoma.

SECTION THREE: It being immediately necessary for the preservation of the public peace, health and safety of the citizens of the City of Alva, Oklahoma, that this ordinance be passed without delay, an emergency is hereby declared to exist, by reason whereof this ordinance shall take effect and be in full force from and after its passage, approval and publication.


