

ORDINANCE NO. 823

AN ORDINANCE ANNEXING CERTAIN TERRITORY TO THE CITY OF ALVA, WOODS COUNTY, OKLAHOMA; AND DECLARING AN EMERGENCY.

WHEREAS, the owners of the following described lands now owned by them and now adjoining the City of Alva, Oklahoma, have petitioned the City Council of the City of Alva, Oklahoma and requested said lands be annexed to said City and become a part of the territory included within the corporate limits of said City, said lands and premises being described in said request and hereinafter particularly described; and

WHEREAS, it is the opinion of the Mayor and Council of the City of Alva, that said request should be granted;

NOW, THEREFORE, BE IT ORDAINED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF ALVA, OKLAHOMA:

SECTION ONE: That all of certain pieces and parcels of land now adjoining the City of Alva, and bounded and described as follows, to-wit:

Commencing at the Southeast (SE) corner of the Southeast Quarter (SE/4) of Section Twenty-six (26), Township Twenty-seven (27) North, Range Fourteen (14) W.I.M., Woods County, Oklahoma; thence West on the South line of the Southeast Quarter (SE/4) for a distance of 2429.65 feet; thence North on the East line of GREENFIELD ESTATES ADDITION for a distance of 1323.37 feet; thence North 89°46'44" East along the North line of the South Half of the Southeast Quarter (S/2 SE/4) a distance of 598.94 feet to the point of BEGINNING; thence North 89°46'44" East for a distance of 665.00 feet; thence South for a distance of 50.00 feet; Thence South 89°46'44" West a distance of 665.00 feet; thence North for a distance of 50.00 feet to the Point of Beginning, containing 0.763 acres, more or less,

be and the same are hereby annexed to and shall hereafter be a part of the territory included within the corporate limits of the City of Alva, Woods County, Oklahoma.


