**ORDINANCE # 2008-04**

**AN ORDINANCE ANNEXING CERTAIN TERRITORY AND INCORPORATING THE SAME WITHIN THE CORPORATE BOUNDARIES OF THE CITY OF ANTLERS, OKLAHOMA, PURSUANT TO THE PROVISIONS OF TITLE 11 SECTION 21-105 OF THE OKLAHOMA STATUTES.**

WHEREAS, pursuant to 11 O.S. § 21-103, more than three-fourths of the legal voters and the owners of at least three-fourths (in value) of certain real property contiguous and adjacent to the City of Antlers petitioned the City of Antlers to annex the following described real property located in the County of Pushmataha, State of Oklahoma to-wit:

All of that piece or portion of land lying between State Highway 3 and SE 3rd Street, including all of SE 3rd Street, commencing at the intersection of State Highway 3 and SE 3rd Street and running westerly to the existing city limits of Antlers, Oklahoma;

AND

A piece or parcel of land lying on the South side of SE 3rd Street, beginning at SE "M" Street and running East along SE 3rd Street a distance of 1,320 feet long and a width of 350 feet;

AND


All that piece or portion of land lying on the South side of SE 3rd Street, beginning at SE "M" Street and running West along SE 3rd Street that includes Lots 1, 2, 3, 4, 5, 6, 7, 8, 9, 10, 11, and 12, in Block 1 of the Colbert Addition, Lots 1 and 2, of Block 2 of the Colbert Addition, and the 40 feet assigned to SE 4th Street and all of the alley dividing Block 1 of the Colbert Addition, and all of SE "L" Street between Blocks 1 and 2 of Colbert Addition.

WHEREAS, notice of the proposed annexation of the territory described in this ordinance was published in the Antlers American on the May 15, 2008 and May 22, 2008, pursuant to the requirements of 11 O.S. § 21-103.

NOW, therefore be it ordained by the City of Antlers, County of Pushmataha, State of Oklahoma, that the following described lands, situated in Pushmataha County, Oklahoma, to-wit:

All of that piece or portion of land lying between State Highway 3 and SE 3rd Street, including all of SE 3rd Street, commencing at the intersection of State Highway 3 and SE 3rd Street and running westerly to the existing city limits of Antlers, Oklahoma;

A piece or parcel of land lying on the South side of SE 3rd Street, beginning at SE "M" Street and running East along SE 3rd Street a distance of 1,320 feet long and a width of 350 feet;


AND

All that piece or portion of land lying on the South side of SE 3rd Street, beginning at SE "M" Street and running West along SE 3rd Street that includes Lots 1, 2, 3, 4, 5, 6, 7, 8, 9, 10, 11, and 12, in Block 1 of the Colbert Addition, Lots 1 and 2, of Block 2 of the Colbert Addition, and the 40 feet assigned to SE 4th Street and all of the alley dividing Block 1 of the Colbert Addition, and all of SE "L" Street between Blocks 1 and 2 of Colbert Addition.

Are herewith annexed to, included within the limits and shall be a part of the City of Antlers, Oklahoma.

It being necessary for the immediate preservation of the public peace, health and safety of the City of Antlers, Oklahoma and the inhabitants thereof, an emergency is hereby declared to exist, to wit: in order to provide police protection to said territory. By reason whereof, it is necessary that this Ordinance go into full effect and be of force immediately upon its passage and approval.
