ORDINANCE # 2008-05

AN ORDINANCE ANNEXING CERTAIN TERRITORY AND INCORPORATING THE SAME WITHIN THE CORPORATE BOUNDARIES OF THE CITY OF ANTLERS, OKLAHOMA, PURSUANT TO THE PROVISIONS OF TITLE 11 SECTION 21-105 OF THE OKLAHOMA STATUES.

WHEREAS, pursuant to Title 11 Section 21-103 of the Oklahoma Statues, Mattie Cooper, the owner of certain real property contiguous and adjacent to the City of Antlers petitioned the City of Antlers to annex the following described real property located in the County of Pushmataha, State of Oklahoma, to-wit:

A tract of land in the NE/2 SE/4 of Section 5, Township 4 South, Range 16 East described as follows: Beginning at a point of the East boundary of said NE/4 SE/4 20 feet South of the NE corner thereof, Thence West parallel with the North boundary of said division 170 feet; Thence South parallel with the East boundary of said sub-division 200 feet; Thence East parallel with the North boundary 170 feet to the East boundary of NE/4 SE/4; Thence 200 feet North parallel with the West boundary of said sub-division to the point of beginning.



WHEREAS, notice of the proposed annexation of the territory described in this ordinance was published in the Antlers American on July 17, 2008 and July 24, 2008, pursuant to the requirement of Title 11 Section 21-103 of the Oklahoma Statues.

NOW, therefore be it ordained by the City of Antlers, County of Pushmataha, State of Oklahoma, that the following described land, situated in Pushmataha County, Oklahoma, to-wit:

A tract of land in the NE/2 SE/4 of Section 5, Township 4 South, Range 16 East described as follows: Beginning at a point of the East boundary of said NE/4 SE/4 20 feet South of the NE corner thereof, Thence West

parallel with the North boundary of said division 170 feet; Thence South
parallel with the East boundary of said sub-division 200 feet; Thence East
parallel with the North boundary 170 feet to the East boundary of NE/4
SE/4; Thence 200 feet North parallel with the West boundary of said sub-
division to the point of beginning.

Is herewith annexed to, included with the limits and shall be a part of the City of Antlers,
Oklahoma.

It being necessary for the immediate preservation of the public peace, health and safety of the
City of Antlers, Oklahoma and the inhabitants thereof, an emergency is hereby declared to
exist, to-wit: in order to provide police protection to said territory. By reason whereof, it is
necessary that this Ordinance goes into full effect and be of force immediately upon its passage
and approval.
