ORDINANCE # 2008-10

AN ORDINANCE ANNEXING CERTAIN TERRITORY AND INCORPORATING THE SAME WITHIN THE CORPORATE BOUNDARIES OF THE CITY OF ANTLERS, OKLAHOMA, PURSUANT TO THE PROVISIONS OF TITLE 11 SECTION 21-105 OF THE OKLAHOMA STATUES.

WHEREAS, pursuant to Title 11 Section 21-103 of the Oklahoma Statues, U:MAJI, LLC, the owner of certain real property contiguous and adjacent to the City of Antlers petitioned the City of Antlers to annex the following described real property located in the County of Pushmataha, State of Oklahoma, to-wit:

A parcel of land lying in the NW/4 SW/4 of Section 4, Township 4 South, Range 16 East of the I.B & M., described as follows: commencing at the Northwest corner of said NW/4 SW/4; thence S 1° 25'52"E a distance of 193.77 feet; thence N88°34'08"E a distance of 50.00 feet to a point on The East Right of Way Line of State Highway No. 2 and the Point of Beginning; thence S1°25'52"E along said Right of Way Line a distance of 250.00 feet a point on the North Right of Way Line of State Highway No. 3; thence S55°08'19" E E along said Right of Way Line a distance Of 250.00 feet; thence N 34°51'41" E a distance of 400.00 feet; thence N81°38'50" W a distance Of 444.73 feet to the Point of Beginning and containing 2.40 acres.



WHEREAS, notice of the proposed annexation of the territory described in this ordinance was published in the Antlers American on September 11, 2008 and September 18, 2008, pursuant to the requirement of Title 11 Section 21-103 of the Oklahoma Statues.

NOW, therefore be it ordained by the City of Antlers, County of Pushmataha, State of Oklahoma, that the following described land, situated in Pushmataha County, Oklahoma, to-wit:

A parcel of land lying in the NW/4 SW/4 of Section 4, Township 4 South, Range 16 East of the I.B & M., described as follows: commencing at the Northwest corner of said NW/4 SW/4;



thence S 1° 25'52"E a distance of 193.77 feet; thence N88°34'08"E a distance of 50.00 feet to a point on The East Right of Way Line of State Highway No. 2 and the Point of Beginning; thence S1°25'52"E along said Right of Way Line a distance of 250.00 feet a point on the North Right of Way Line of State Highway No. 3; thence S55°08'19" E E along said Right of Way Line a distance Of 250.00 feet; thence N 34°51'41" E a distance of 400.00 feet; thence N81°38'50" W a distance Of 444.73 feet to the Point of Beginning and containing 2.40 acres.

Is herewith annexed to, included with the limits and shall be a part of the City of Antlers, Oklahoma.

It being necessary for the immediate preservation of the public peace, health and safety of the City of Antlers, Oklahoma and the inhabitants thereof, an emergency is hereby declared to exist, to-wit: in order to provide police protection to said territory. By reason whereof, it is necessary that this Ordinance goes into full effect and be of force immediately upon its passage and approval.
