AN ORDINANCE OF THE CITY OF BARNSDALL, A MUNICIPAL CORPORATION, EXTENDING THE CORPORATE LIMITS OF THE CITY OF BARNSDALL, OSAGE COUNTY, STATE OF OKLAHOMA, ALL WITHIN THE NORTHEAST QUARTER (NE/4) OF THE SOUTHWEST QUARTER (SW/4) OF SECTION 17, TOWNSHIP 24 NORTH, RANGE 11 EAST OF THE INDIAN MERIDIAN, OSAGE COUNTY, OKLAHOMA.

WHEREAS, by the majority vote of the City Council of the City of Barnsdall at a regular session of the City Council held on the 4th day of January, 2000, it was approved to annex the real property listed below into the corporate limits of the City of Barnsdall; and

WHEREAS, written permission was given by the real property owners pursuant to *Okla. Stat. Ann. Tit. 11 21-103*, wherein all of the property owners of the annexed territory did execute a written consent attached hereto so that publication of the proceedings is unnecessary; and

WHEREAS, it is deemed advisable and for the best interests of the inhabitants of said tract and the City of Barnsdall that the corporate limits of said City be extended to include said tract; and

WHEREAS, City utilities are already available to the real property owners located within said tract.

BE IT ORDAINED by the City Council for the City of Barnsdall, Oklahoma, meeting in regular session at City Hall, Barnsdall, Osage County, Oklahoma, on this 4th day of January, 2000, as follows, to wit:

Section One (1): Annexation of Territory.



There is hereby annexed to the City of Barnsdall, County of Osage, State of Oklahoma, and incorporated within the corporate boundaries thereof, the following territory adjoining the present corporate boundaries of the City of Barnsdall, to wit:

All that part of the Northeast Quarter (NE/4) of the Southwest Quarter (SW/4) lying South of Highway #11 in Section 17, Township 24 North, Range 11 East of the Indian Meridian, LESS AND EXCEPT the following described tract: Beginning at the Southwest Corner (SW/C) of the Northeast Quarter (NE/4) of the Southwest Quarter (SW/4) of Section 17; thence N 0°41'19" E along the West line of said Northeast Quarter (NE/4) of the Southwest Quarter (SW/4) 565.82 feet to a point on the South right-of-way line of State Highway 11; thence S 86° 16' E along said South right-of-way line, 330.31 feet; thence S 9°0'51" W 551.52 feet to a point on the South line of said Northeast Quarter (NE/4) of the Southwest Quarter (SW/4); thence N 89°54'1" W along the South line of said Northeast Quarter (NE/4) of the Southwest Quarter (SW/4), 250 feet to the point of beginning.




Section Two (2): Severability


