ANNEXATION ORDINANCE OF THE TOWN OF BIG CABIN,
CRAIG COUNTY, OKLAHOMA

NOW on this 12th day of December, 2002, there came before the before the Board of Trustees of the Town of Big Cabin, Craig County, Oklahoma, the question of Annexation of certain property immediately adjacent to and adjoining said Town of Big Cabin. Said property was purchased by the Board of Trustees of Big Cabin, Craig County, Oklahoma, on the 20th day of June, 2002 by said Township for the purpose of being utilized by the Town of Big Cabin, Craig County, Oklahoma as a Town Park by said Municipality.

A copy of the legal description of said property is hereto attached and referenced in the description attached hereto and referenced as site map.

The Town of Big Cabin being the owner of the property in question, and said property being immediately adjacent and adjoining said Township, and there being no other ownership interest within said area, that said Township hereby gives legal notice that through this Ordinance they annex said property hereinafter referenced as Big Cabin Town Park into the corporate limits of the Town of Big Cabin, Craig County, Oklahoma.

The Board of Trustees have recorded in the Offices of the County Clerk of Craig County, Oklahoma a plat map showing the annexed area known as Big Cabin Town Park Lot, and properly annexing same within the boundaries of the corporate limits of Big Cabin, Oklahoma, all pursuant to 11 O.S.A. 21-104. The Big Cabin City Clerk is hereby instructed by the Mayor to file and publish a duly certified copy of this Ordinance along with the map/plat of the territory in the Office of the County Clerk within Craig County, Oklahoma immediately subsequent to the passage by this body and publication.

Passed and approved by the Board of Trustees of the Town of Big Cabin, Oklahoma, this 12th day of December, 2002.

Being immediately necessary for the preservation of the public health, peace, safety, and welfare of the Town of Big Cabin, Oklahoma and its citizens, an emergency is hereby declared to exist by reason of which this Ordinance shall take

effect and be in full force and effect from and after its passage, approval and publication.

Passed and approved, the emergency clause voted on separately this 12th day of December, 2002.
