

AN ORDINANCE ANNEXING ALL OF ROCK ISLAND ADDITION NOT PREVIOUSLY ANNEXED, IN SECTION 34, TOWNSHIP 10 NORTH, RANGE 11 WEST, I.M., AN ADDITION TO THE TOWN OF BINGER, OKLAHOMA; AND DECLARING AN EMERGENCY.

BE IT ORDAINED by the Town Board of Trustees of Binger, Oklahoma:

**Section 1. Certain Areas Annexed to Town of Binger.** That the corporate limits of the Town of Binger, Oklahoma, be and they are hereby extended to include within the said limits, the following described platted area adjacent or contiguous to the Town:

All of the Rock Island Addition to the Town of Binger, Oklahoma, not previously annexed, to include a tract situated in the Southwest Quarter (SW/4) of Section Twenty-six (26), Township Ten (10) North, Range Eleven (11) West, I.M., Caddo County, Oklahoma; more particularly described as follows: Beginning at a point 1225.2 feet South and 420.67 feet West from the center of said Section Twenty-six (26); thence South 89°43'52" West a distance of 481.3 feet; thence North 40°58'08" West a distance of 686.1 feet; thence North 21°13'08" West a distance of 819.2 feet; thence South 86°44'08" East a distance of 535.7 feet; thence South 31°09'08" East a distance 660.0 feet; thence South 34°14'08" East a distance of 765.0 feet to P.O. B.; containing 15.38 acres, more or less;

and that all of the above described platted area not now within the limits of the Town of Binger, Oklahoma, be and the same is annexed to the Town of Binger, Oklahoma.

**Section 2. Emergency.** It being immediately necessary that the above-described tract adjoining the Town of Binger, Oklahoma, be extended the services and protection of said Town, an emergency is hereby declared to exist by reason whereof this Ordinance shall become effective July 11, 1994.


