AN ORDINANCE ANNEXING TO THE CITY OF BIXBY, OKLAHOMA ALL OF EAGLE ROCK, AN ADDITION SITUATED IN THE SE/4 OF SECTION 10, TOWNSHIP 17 NORTH, RANGE 13 EAST, TULSA COUNTY, STATE OF OKLAHOMA

WHEREAS, All of Eagle Rock, an Addition Situated in the SE/4 of Section 10, Township 17 North, Range 13 East, Tulsa County, State of Oklahoma, is adjacent to and abuts the present corporate city limits of the City of Bixby, Oklahoma; and

WHEREAS, the City of Bixby, Oklahoma is already providing water and sanitary sewer service to All of Eagle Rock, an Addition Situated in the SE/4 of Section 10, Township 17 North, Range 13 East, Tulsa County, State of Oklahoma, and such Subdivision has been platted and developed in accord with the various rules, regulations and practices adopted by the City of Bixby, Oklahoma with respect to, among other things, streets, easements, and utility services; and

WHEREAS, the owners of All of Eagle Rock, an Addition Situated in the SE/4 of Section 10, Township 17 North, Range 13 East, Tulsa County, State of Oklahoma, have consented to the annexation of such land by the City of Bixby, Oklahoma, pursuant to the provisions of Okl. Stat. tit. 11, §21-103; and

WHEREAS, the annexation of All of Eagle Rock, an Addition Situated in the SE/4 of Section 10, Township 17 North, Range 13 East, Tulsa County, State of Oklahoma by the City of Bixby, Oklahoma will be for the benefit of the owners of such land, and is necessary for the health, welfare and safety of the citizens of the City of Bixby, Oklahoma.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF BIXBY, OKLAHOMA:

1. That All of Eagle Rock, an Addition Situated in the SE/4 of Section 10, Township 17 North, Range 13 East, Tulsa County, State of Oklahoma, be and the same is hereby annexed to and added to the City of Bixby, Oklahoma, and the corporate city limits of the City of Bixby, Oklahoma be and hereby are extended to include such land.

2. That from and after the enactment of this Ordinance All of Eagle Rock, an Addition Situated in the SE/4 of Section 10, Township 17 North, Range 13 East, Tulsa County, State of Oklahoma, shall be part of the City of Bixby, Oklahoma, and all such property shall be and is hereby declared to be subject to the jurisdiction, control, laws and ordinances of the City of Bixby, Oklahoma, in all respects and particulars.
