



ORDINANCE NO. 892

AN ORDINANCE ANNEXING TO THE CITY OF BIXBY, OKLAHOMA, AND INCLUDING THE SAME WITHIN THE CORPORATE LIMITS OF THE SAID CITY OF BIXBY, OKLAHOMA, DECLARING THE SAME SUBJECT TO THE ORDINANCES OF THE CITY OF BIXBY, OKLAHOMA AND REQUIRING THE CITY CLERK TO FILE A CERTIFIED COPY OF THIS ORDINANCE WITH THE COUNTY CLERK OF TULSA COUNTY, STATE OF OKLAHOMA, AND DECLARING AN EMERGENCY

Whereas, of the 12 day of July, 2004 a Petition in writing was presented to the City Council of the City of Bixby, Oklahoma, a municipal corporation, requesting the annexation and incorporation within the corporate limits of said City of Bixby, Oklahoma, a certain area of land, all of which is described in the Petition for Annexation which is more particularly described as follows, to wit:

The West 440 feet of the West One-half (W/2) of the Southeast Quarter (SE/4) of Section Seventeen (17), Township Seventeen (17) North, Range Thirteen (13) East of the Indian Base and Meridian, Tulsa County, State of Oklahoma, according to the U.S. Government Survey thereof.

Whereas, said property is contiguous and adjacent to the present limits of the incorporated City of Bixby, Oklahoma, and is not presently incorporated in said City;

Whereas, it appears that under the laws made and provided by the State of Oklahoma in such cases, said lands hereinabove described may be lawfully annexed to the City of Bixby, Tulsa County, Oklahoma, and henceforth, for all purposes, considered a part of said City, and

Whereas, an accurate map of the area for which annexation is sought has been filed with the City Council of the City of Bixby, which map is duly certified by the Mayor of the City of Bixby;

NOW, THEREFORE, be it ordained by the City Council of the City of Bixby, Oklahoma, in regular session, duly assemble, after public comment in a duly advertised public hearing direct as follows:

Section 1. That the above described land be and hereby are annexed to the City of Bixby, Oklahoma, said land being situated in the Tulsa County, Oklahoma.

Section 2. That all laws and ordinances of said City of Bixby be, and the same are hereby declared to be in effect within the territory hereinabove described.

Section 3. That there be filed in the Offices of the County Clerk of Tulsa County, Oklahoma, a true and correct copy of this Ordinance, together with an accurate map of the territory hereby annexed.

Section 4. The City Council further repeals all ordinance or parts thereof in conflict herewith.
