



ORDINANCE NO. 283

AN ORDINANCE PROVIDING FOR THE ANNEXATION OF LAND LOCATED IN THE S/2, NW/4 OF SECTION 14-3-5 OF CIMARRON COUNTY INTO THE CORPORATE LIMITS OF THE CITY OF BOISE CITY (LAND LOCATED SOUTH OF STATE HIGHWAY 64 ON HART STREET)

WHEREAS, the City of Boise City has received a petition from at least three-fourths of the property owners of the following described tract of land, and;

WHEREAS, this property is adjacent and contiguous to the corporate limits of the City of Boise City, and;

WHEREAS, the petition is to be formally presented to the City Council on February 13, 2006, and;

WHEREAS, the notice of the presentation of the petition has been published in the January 25, 2006 and the February 1, 2006 issues of the Boise City News, and;

WHEREAS, the City of Boise City desires to annex this property into the corporate limits of the City, now therefore;

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF BOISE CITY, OKLAHOMA, THAT:

Section 1. The following described tract of land is hereby annexed into the corporate limits of the City of Boise City, Oklahoma:

A TRACT OF LAND COMPRISING 2.81 ACRES, MORE OR LESS, SITUATED IN THE SOUTH HALF OF THE NORTHWEST QUARTER (S/2NW/4) OF SECTION FOURTEEN (14), TOWNSHIP THREE (3), NORTH OF RANGE FIVE (5), EAST OF THE CIMARRON MERIDIAN, CIMARRON COUNTY, OKLAHOMA, AND MORE PARTICULARLY DESCRIBED, TO-WIT:

BEGINNING AT A POINT IN THE SOUTHWEST CORNER OF SAID TRACT THREE-HUNDRED-FIFTY FEET (350') NORTH, THENCE EAST THREE-HUNDRED-FIFTY (350'), THENCE SOUTH THREE-HUNDRED-FIFTY FEET (350'), THENCE WEST THREE-HUNDRED-FIFTY FEET (350') TO THE POINT OF BEGINNING, AND CONTAINING TWO AND EIGHTY-ONE HUNDREDTHS (2.81) ACRES, MORE OR LESS.


