

ORDINANCE NO. 285

AN ORDINANCE PROVIDING FOR THE ANNEXATION OF LAND LOCATED IN THE NW/4 OF SECTION 10-3-5 OF CIMARRON COUNTY INTO THE CORPORATE LIMITS OF THE CITY OF BOISE CITY (LAND LOCATED NORTH OF VAN BUREN STREET AND WEST OF U.S. HIGHWAY 287)

WHEREAS, the City of Boise City has received a petition from at least three-fourths of the property owners of the following described tract of land, and;

WHEREAS, this property is adjacent and contiguous to the corporate limits of the City of Boise City, and:

WHEREAS, the petition is to be formally presented to the City Council on November 13, 2006, and;

WHEREAS, the notice of the presentation of the petition has been published in the November 1, 2006 and the November 8, 2006 issues of the Boise City News, and;

WHEREAS, the City of Boise City desires to annex this property into the corporate limits of the City, now therefore

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF BOISE CITY, OKLAHOMA, THAT:

Section 1. The following described tracts of land are hereby annexed into the corporate limits of the City of Boise City, Oklahoma:


A TRACT OF LAND IN THE WEST HALF OF THE NORTHWEST QUARTER (W/2 NW/4) OF SECTION TEN (10) IN TOWNSHIP THREE (3) NORTH OF RANGE FIVE (5), EAST OF THE CIMARRON MERIDIAN IN CIMARRON COUNTY, OKLAHOMA, BEING ALL THAT PROPERTY LOCATED WEST OF THE RIGHT OF WAY LINE OF US HIGHWAY 287 (AS ESTABLISHED IN THAT EASEMENT RECORD IN VOLUME 27 AT PAGE 283 OF THE RECORDS IN THE OFFICE OF THE COUNTY CLERK OF CIMARRON COUNTY) AND LOCATED NORTH OF THAT LINE WHICH IS 860.7 FEET NORTH OF AND PARALLEL TO THE SOUTH LINE OF THE SAID NORTHWEST QUARTER, TOGETHER WITH EASEMENTS FOR UTILITY SERVICES APPURTENANT TO SAID TRACT RESERVED IN THOSE DEEDS RECORDED IN BOOK 331 AT PAGE 309 AND IN BOOK 299 AT PAGE 520 OF THE RECORDS IN THE OFFICE OF THE COUNTY CLERK FOR CIMARRON COUNTY, OKLAHOMA.


