

ORDINANCE NO. 2827

An Ordinance repealing Ordinance No. 2825 changing the name of 79th Street in The Villas On The Green, The Courtyards, Lochmere II and The Cottages all platted subdivisions in the Forest Ridge Development of the City of Broken Arrow, Wagoner County, Oklahoma; Repealing all ordinances to the contrary; and declaring an emergency.

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF BROKEN ARROW:

SECTION I. Broken Arrow Ordinance No. 2825 is hereby repealed in its entirety.

SECTION II. Any ordinance or parts of ordinances found to be in conflict herewith are hereby repealed.

SECTION III. An emergency exists for the preservation of the public health, peace and safety, and therefore this ordinance shall become effective from and after the time of its passage and approval.



An ordinance changing the name of 79th Street in The Villas On The Green, The Courtyards, Lochmere II and The Cottages all platted subdivisions in the Forest Ridge Development of the City of Broken Arrow, Wagoner County, Oklahoma; Repealing all ordinances to the contrary.

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF BROKEN ARROW:

SECTION I. The name of North and South 79th Street in The Villas on the Green, The Courtyards, Lochmere II and The Cottages, all platted subdivisions in the east half of Section 10, Township 18 East, Range 15 North, in Wagoner County, Oklahoma are hereby changed as follows:
