ORDINANCE NO. 2011-05

AN ORDINANCE ANNEXING TERRITORY CONTIGUOUS TO
CALERA, BRYAN COUNTY, OKLAHOMA

WHEREAS, it is necessary for the preservation of the public peace, health, safety, and welfare of the citizens of the Town of Calera, Bryan County, Oklahoma, that an ordinance be passed annexing territory contiguous to the Town of Calera, Bryan County, Oklahoma.

BE IT ORDAINED BY THE BOARD OF TRUSTEES OF THE TOWN OF CALERA
BRYAN COUNTY, OKLAHOMA THAT:

Section 1: Pursuant to Oklahoma Statutes certain real property hereinafter described has been considered by the Board of Trustees of the Town of Calera, Bryan County, Oklahoma for annexation. The notice required by law was duly published and the following described real property contiguous to the Town of Calera, Bryan County, Oklahoma is annexed to the Town of Calera, Bryan County, Oklahoma, to-wit:

Section 2: The boundaries of the Town of Calera, Bryan County, Oklahoma are hereby enlarged to include the above described real property and Section 1-110 of the Ordinances of Calera, Bryan County, Oklahoma is hereby amended to reflect the increasing of the boundaries of the Town of Calera, Bryan County, Oklahoma, by the annexation of the above described real property.

Section 3: A detailed Map outlining the proposed boundaries of the Town of Calera, Bryan County, Oklahoma is shown on Exhibit "A"

Section 4: That the streets, avenues and utility easements are hereby dedicated to the public use as fully and completely and to the same extent and degree as if they had been included in the original Government Survey of the Town of Calera, Bryan County, Oklahoma.

Section 5: Pursuant to Oklahoma Statutes, for any real property herein described that may not have been previously platted and recorded, a plan for extension of Town of Calera, Bryan County, Oklahoma services provide, to-wit:

Section 6: That invalidity of any section of provisions of the Ordinance shall not invalidate any other sections of provisions thereof.


Section 7: Emergency Clause: that the territory hereby annexed to the Town of Calera, Oklahoma, and the inhabitants thereof, being without sufficient police, fire and sanitary protection it is necessary for the preservation of the public peace, health, safety, and welfare, that an emergency is hereby declared to exist by reason whereof, this Ordinance shall be in full force and effect immediately from and after its passage and approval, as required by law.

- ALL THAT PART OF HIGHWAY 70E A.K.A. SR70E RIGHT-OF-WAY LOCATED IN THE S/2 OF S/2 OF S/2 OF SECTION 19, TOWNSHIP 7 SOUTH, RANGE 9 EAST OF THE INDIAN BASE AND MERIDIAN, BRYAN COUNTY, OKLAHOMA.
- ALL THAT PART OF HIGHWAY 70E A.K.A. SR70E RIGHT-OF-WAY LOCATED IN THE N/2 OF N/2 OF N/2 OF SECTION 30, TOWNSHIP 7 SOUTH, RANGE 9 EAST OF THE I.B.M., BRYAN COUNTY, OKLAHOMA.
