II.
That the present Town limits do not include certain municipally operated properties.

III.
That by the proposed annexation, the sewer treatment plant located on land owned by the Town of Cameron shall be included in the municipal limits of the Town of Cameron.

IV.
That by the proposed annexation, commercial establishments and business development along Highway #112, adjacent or contiguous to the Town of Cameron shall be incorporated into the municipal limits of the Town of Cameron.

V.

It is the intent of the Town of Cameron, LeFlore County, Oklahoma, when financially practicable, to provide its residents including the residents of the proposed annexed territory, adequate public services through the maintenance and expansion of existing public utility service, highways, police and fire protection, and all attendant duties a town may offer to its citizens.

VI.

It is the information and belief that the citizens living with the proposed annexed boundaries set forth in Exhibit "A" do not object to being annexed and become residents of the Town of Cameron, LeFlore County, Oklahoma.

VII.

The territory proposed to be annexed is attached hereto as Exhibit "B".

Attached hereto and fully incorporated herein as Exhibit "C" is an accurate map verified by affidavit and reflecting the real estate description set forth in Exhibit B above.




