

ORDINANCE NO. 863

AN ORDINANCE ANNEXING TO THE CITY OF CLINTON, OKLAHOMA, CERTAIN TRACT OF LAND SITUATED IN THE NORTHEAST QUARTER OF SECTION 34, TOWNSHIP NORTH, RANGE 17 WEST OF THE INDIAN MERIDIAN CUSTER COUNTY, OKLAHOMA CONTAINING 29.714 ACRES AND DECLARING AN EMERGENCY.

WHEREAS, the City Council of the City of Clinton, Oklahoma, deems it proper to annex the addition of the tract of land hereibelow described and that such annexation will rebound to the benefit of said City of Clinton, and

WHEREAS, the owner of the land proposed for annexation is the Clinton Industrial Authority and they have given consent to the City of Clinton that the subject property be annexed by and to the City of Clinton and thereby made a part of the land area within the corporate boundaries of the City of Clinton, and

WHEREAS, subject property is hereby described as:

Beginning at a point 433.96 feet West of the Northeast corner of said NE/4, said point being on the North line of said NE/4; THENCE N 89°37'25" W and along said North line a distance of 712.63 feet to a point on the centerline of State Highway No. 14; THENCE Southeasterly on a curve to the left, with a radius of 5721.58 feet and along said centerline a distance of 1347.27 feet (with a long chord bearing of S14°01'11" E 1347.17 feet); THENCE Southeasterly on a curve to the left, with a radius of 1652.76 feet and along said centerline a distance of 721.15 feet (with a long chord bearing of S32°50'00"E 715.43 feet); THENCE S45°20'00"E and along said centerline a distance of 195.28 feet to a point on the West right-of-way of the S.L. and S.F. Railroad; THENCE N14°27'15"E and along said right-of-way a distance of 269.42 feet; THENCE Northerly along said right-of-way on a curve to the left with a radius of 2814.79 feet a distance of 1375.97 feet (with a long chord bearing of N0°27'00"E 1362.31 feet); THENCE N89°37'25"W a distance of 96.61 feet; THENCE N16°18'30"W a distance of 431.44 feet to the point of beginning, containing 29.714 acres more or less.

NOW, THEREFORE, be it ordained by the City Council of the City of Clinton, Oklahoma:



SECTION I. The subject tract is contiguous to the current corporate limits of the City of Clinton and is hereby annexed and added to the City of Clinton, Oklahoma.
