AN ORDINANCE ACCEPTING, ADDING AND ANNEXING TO THE CITY OF COLLINSVILLE, TULSA COUNTY, OKLAHOMA, ALL THAT CERTAIN REAL ESTATE BEING MORE PARTICULARLY DESCRIBED HEREINAFTER; PROVIDING THAT SAID REAL ESTATE SHALL BE PART OF THE CITY OF COLLINSVILLE, OKLAHOMA, AND ALL PERSONS RESIDING THEREIN, IF ANY, AND ALL PROPERTY SITUATED THEREIN, SHALL BE SUBJECT TO THE JURISDICTION, CONTROL, LAWS AND ORDINANCES OF THE CITY OF COLLINSVILLE, OKLAHOMA; DIRECTING NOTIFICATION, AND DECLARING AN EMERGENCY.

WHEREAS, the City of Collinsville, Oklahoma, a municipal corporation, abuts, adjoins and is contiguous to unplatted property hereinafter described, and;

WHEREAS, the City of Collinsville, Oklahoma, desires to annex the property which is hereinafter described, and;

WHEREAS, the owner of the property to be annexed has consented to the annexation thereof, and;

WHEREAS, it is the desire of the Mayor and Board of City Commissioners to annex said territory and to extend the boundaries of said City so as to include said property within its corporate limits.

**NOW, THEREFORE, BE IT ORDAINED BY THE MAYOR AND BOARD OF CITY COMMISSIONERS OF THE CITY OF COLLINSVILLE, OKLAHOMA, THAT:**

**SECTION 1:** The following described land lying within the County of Tulsa, State of Oklahoma, and which is adjacent to, abutting and contiguous to the present corporate limits of the City of Collinsville, a municipal corporation, be and the same, is hereby annexed and added to the City of Collinsville, Oklahoma, and the boundaries of the City of Collinsville are extended so as to include said property, to wit:

A TRACT OF LAND WHICH IS A PART OF THE NW/4 OF THE NE/4 AND A PART OF THE NE/4 OF THE NW/4 OF SECTION 30, T-22-N, R-14-E, TULSA COUNTY, OKLAHOMA, MORE PARTICULARLY DESCRIBED AS FOLLOWS, TO WIT; BEGINNING AT THE NW CORNER OF THE NE/4 OF SECTION 30, T-22-N, R-14-E, TULSA COUNTY, OKLAHOMA, THENCE DUE EAST ALONG THE NORTH LINE OF SAID NE/4 A DISTANCE OF 468.00 FEET, THENCE S 00°06'52" E A DISTANCE OF 302.02 FEET, THENCE DUE EAST A DISTANCE OF 257.40 FEET, THENCE DUE SOUTH A DISTANCE OF 358.85 FEET TO A POINT ON THE NORTH LINE OF THE SE/4 OF THE NW/4 OF THE NE/4 OF SAID SECTION 30, THENCE N 89°59'13" W ALONG THE NORTH LINE OF SAID SE/4 OF THE NW/4 OF THE NE/4 A DISTANCE OF 63.89 FEET TO THE NE CORNER OF THE SW/4 OF THE NW/4 OF THE NE/4 OF SAID SECTION 30, THENCE S 00°06'14 E ALONG THE EAST LINE OF SAID SW/4 OF THE NW/4 OF THE NE/4 A DISTANCE OF 660.81 FEET TO THE SE CORNER OF SAID SW/4 OF THE NW/4 OF THE NE/4, THENCE N 89°58'27" W ALONG THE SOUTH LINE OF SAID SW/4 OF THE NW/4 OF THE NE/4 A DISTANCE OF 660.66 FEET TO THE SW

CORNER OF SAID SW/4 OF THE NW/4 OF THE NE/4, THENCE CONTINUING N 89°58'27" W ALONG THE SOUTH LINE OF THE NE/4 OF THE NW/4 OF SAID SECTION 30 A DISTANCE OF 264.34 FEET TO A POINT, THENCE N 00°07'11" W A DISTANCE OF 1321.23 FEET TO A POINT ON THE NORTH LINE OF SAID NE/4 OF THE NW/4, THENCE DUE EAST ALONG THE NORTH LINE OF SAID NE/4 OF THE NW/4 A DISTANCE OF 264.45 FEET TO THE POINT OF BEGINNING. CONTAINING 27.26 ACRES MORE OR LESS.



**SECTION 3:** That from and after the date of publication hereof, the effective date of this Ordinance, the above described real estate shall be part of the City of Collinsville, Oklahoma, in **Ward IV** thereof, and bearing a zoning classification of **AG Agriculture**, and all persons residing therein, and all property situated therein and thereon, shall be and are hereby declared to be subject to the jurisdiction, control, laws and ordinances of the City of Collinsville, Oklahoma, in all respects and particulars.




