AN ORDINANCE ACCEPTING, ADDING AND ANNEXING TO THE CITY OF COLLINSVILLE, TULSA COUNTY, OKLAHOMA, ALL THAT CERTAIN REAL ESTATE BEING MORE PARTICULARLY DESCRIBED HEREINAFTER; PROVIDING THAT SAID REAL ESTATE SHALL BE PART OF THE CITY OF COLLINSVILLE, OKLAHOMA, AND ALL PERSONS RESIDING THEREIN, IF ANY, AND ALL PROPERTY SITUATED THEREIN, SHALL BE SUBJECT TO THE JURISDICTION, CONTROL, LAWS AND ORDINANCES OF THE CITY OF COLLINSVILLE, OKLAHOMA; DIRECTING NOTIFICATION, AND DECLARING AN EMERGENCY.

WHEREAS, the City of Collinsville, Oklahoma, a municipal corporation, abuts, adjoins and is contiguous to unplatted property hereinafter described, and;

WHEREAS, the City of Collinsville, Oklahoma, desires to annex the property which is hereinafter described, and;

WHEREAS, the owner of the property to be annexed has consented to the annexation thereof, and;

WHEREAS, it is the desire of the Mayor and Board of City Commissioners to annex said territory and to extend the boundaries of said City so as to include said property within its corporate limits.

NOW, THEREFORE, BE IT ORDAINED BY THE MAYOR AND BOARD OF CITY COMMISSIONERS OF THE CITY OF COLLINSVILLE, OKLAHOMA, THAT:

SECTION 1: The following described land lying within the County of Tulsa, State of Oklahoma, and which is adjacent to, abutting and contiguous to the present corporate limits of the City of Collinsville, a municipal corporation, be and the same, is hereby annexed and added to the City of Collinsville, Oklahoma, and the boundaries of the City of Collinsville are extended so as to include said property, to wit:

A TRACT OF LAND THAT IS PART OF THE NORTH HALF (N/2) OF SECTION 30, TOWNSHIP 22 NORTH, RANGE 14 EAST OF THE LB. & M., TULSA COUNTY, OKLAHOMA, MORE PARTICULARLY DESCRIBED AS FOLLOWS:

BEGINNING AT THE NORTHWEST CORNER OF LOT 13, BLOCK 3, OF STONEGATE ESTATES, AN ADDITION TO TULSA COUNTY, OKLAHOMA, ACCORDING TO THE RECORDED PLAT THEREOF; THENCE S 0°07'40" E FOR 289.49 FEET; THENCE DUE WEST FOR 527.54 FEET; THENCE DUE NORTH FOR 289.40 FEET; THENCE N 89°59'26" E FOR 526.90 FEET TO THE POINT OF BEGINNING.

SAID TRACT CONTAINS 3.50 ACRES MORE OR LESS.




SECTION 3: That from and after the date of publication hereof, the effective date of this Ordinance, the above described real estate shall be part of the City of Collinsville, Oklahoma, in **Ward I** thereof, and bearing a zoning classification of **AG Agriculture**, and all persons residing therein, and all property situated therein and thereon, shall be and are hereby declared to be subject to the jurisdiction, control, laws and ordinances of the City of Collinsville, Oklahoma, in all respects and particulars.


PASSED, and the **EMERGENCY CLAUSE** ruled upon separately **AND APPROVED** this 20 Day of March 2006.


