

**CITY OF COLLINSVILLE, OKLAHOMA
ORDINANCE NUMBER 858**

AN ORDINANCE ACCEPTING, ADDING AND ANNEXING TO THE CITY OF COLLINSVILLE, TULSA COUNTY, OKLAHOMA, ALL THAT CERTAIN REAL ESTATE BEING MORE PARTICULARLY DESCRIBED HEREINAFTER; PROVIDING THAT SAID REAL ESTATE SHALL BE PART OF THE CITY OF COLLINSVILLE, OKLAHOMA, AND ALL PERSONS RESIDING THEREIN, IF ANY, AND ALL PROPERTY SITUATED THEREIN, SHALL BE SUBJECT TO THE JURISDICTION, CONTROL, LAWS AND ORDINANCES OF THE CITY OF COLLINSVILLE, OKLAHOMA; DIRECTING NOTIFICATION, AND DECLARING AN EMERGENCY.

WHEREAS, the City of Collinsville, Oklahoma, a municipal corporation, abuts, adjoins and is contiguous to platted property hereinafter described, and;

WHEREAS, the City of Collinsville, Oklahoma, desires to annex the property which is hereinafter described, and;

WHEREAS, the owner of the property to be annexed has petitioned for the annexation thereof, and consented to said annexation, and;

WHEREAS, it is the desire of the Mayor and Board of City Commissioners to annex said territory and to extend the boundaries of said City so as to include said property within its corporate limits.

NOW, THEREFORE, BE IT ORDAINED BY THE MAYOR AND BOARD OF CITY COMMISSIONERS OF THE CITY OF COLLINSVILLE, OKLAHOMA, THAT:

SECTION 1: The following described land lying within the County of Tulsa, State of Oklahoma, and which is adjacent to, abutting and contiguous to the present corporate limits of the City of Collinsville, a municipal corporation, be and the same, is hereby annexed and added to the City of Collinsville, Oklahoma, and the boundaries of the City of Collinsville are extended so as to include said property, to wit:

Lots 2 and 3, Block 1, Crimson Park Addition, Tulsa County, Oklahoma.


SECTION 2: The City Clerk of the City of Collinsville, Oklahoma, is hereby directed to file a copy of the Ordinance, together with a plat or map or survey defining boundaries of the above described annexed territory, with the office of the County Clerk of Tulsa County, State of Oklahoma.

SECTION 3: That from and after the date of publication hereof, the effective date of this Ordinance, the above described real estate shall be part of the City of Collinsville, Oklahoma, in **Ward IV** thereof, and bearing a zoning classification of **RE (Residential Estate District)**, and all persons residing therein, and all property situated therein and thereon, shall be and are hereby declared to be subject to the jurisdiction, control, laws and ordinances of the City of Collinsville, Oklahoma, in all respects and particulars.

SECTION 4: An emergency exists for the preservation of public health, peace and safety and, therefore this ordinance shall become effective from and after the date of its passage and approval.


PASSED, and the **EMERGENCY CLAUSE** ruled upon separately **AND APPROVED** this **3rd Day of October, 2011**.








300' Radius
