

**ORDINANCE NO. 605**

**AN ORDINANCE ANNEXING A CERTAIN CONTIGUOUS TRACT OF LAND FORMING A PART OF SECTION 29, TOWNSHIP 18 NORTH, RANGE 15 EAST OF THE INDIAN MERIDIAN IN WAGONER COUNTY, OKLAHOMA; PROVIDING FOR ZONING CLASSIFICATION; MAKING ALL OF SAID TERRITORY A PART OF WARD 4 OF THE CITY OF COWETA, OKLAHOMA; REPEALING ALL ORDINANCES OR PARTS OF ORDINANCES IN CONFLICT HEREWITH AND DECLARING AN EMERGENCY.**

**BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF COWETA**

**Section 1.** That the following described tract of land lying contiguous to the present corporate limits of the City of Coweta, to wit:

E ½ OF SW ¼ OF NW ¼ OF SECTION 29, township 18 North, Range 15 East of the Indian Base and Meridian, Wagoner County, State of Oklahoma.

**Section 2.** The City Council of the City of Coweta, Oklahoma finds the above described tract of land adjacent to or contiguous to property already within the municipal limits of said City of Coweta.

**Section 3.** That the above described property is currently zoned under County of Wagoner designation AG and shall be zoned to the City of Coweta AG (Agriculture) classification.

**Section 4.** That the above described property shall be part of Ward 4 of the City of Coweta.


**Section 5.** That all ordinances or parts of ordinances in conflict herewith, are hereby repealed.

**Section 6.** That if any parts hereof be held invalid or ineffective, the remaining portions shall not be affected but remain in full force and effect.

**Section 7.** That an emergency exists for the preservation of the public health, peace and safety, and therefore that this ordinance shall become effective from and after the time of its passage and approval.







