ORDER

NOW on this 28th day of July, 1997, The Board of County Commissioners of Seminole County met at the regularly set meeting and the Petition For Annexation was presented to the Board concerning lands to be annexed and incorporated into the Town of Cromwell.

That The Board of County Commissioners of Seminole County, after being satisfied that the required statutory notice to all land owners who would be affected by the annexation Order were given notice of The Town Of Cromwells annexation Petition and of the hearing date with the Board of County Commissioners of Seminole County.

That the hearing was held at this time with all The Board of County Commissioners of Seminole County being present. That William D. Huser, attorney for the Town of Cromwell, presented to The Board of County Commissioners of Seminole County the annexation desired and the requirements concerning the same.

The Description of said annexation advancing the North Town Limits of Cromwell North to the I-40 area is described per Attachment "A" together with a map Attachment "B".

Thereafter, people in attendance at said hearing were given the opportunity to express their thoughts and ask questions concerning the same. That Butch Morton being the representative of the State Department of Transportation was present. That after the question and answer period no one objected to the proposed annexation. That thereafter, The Board of County Commissioners of Seminole County; and, each of them voted in the affirmative for the proposed annexation.

**IT IS THEREFORE ORDERED**, by The Board of County Commissioners of Seminole County that the proposed annexation as above described is hereby approved this 28th day of July, 1997.

**FURTHER**, it is directed that a copy of the map supplied by the Town of Cromwell be attached to this Order and that this Order be filed and recorded in the Office of the Seminole County Clerk and a copy of this Order shall be filed in the archives of the Town of Cromwell.

## ATTACHMENT "A"

A strip of land beginning at the Town Limits on the North side of the Town of Cromwell being the width of the right of way of State Highway 56. The Town Limits on the east side of highway No. 56 right of way begin at a point located on the Northwest Corner of the Southwest Quarter of the Northwest Quarter, Section 10, Township 10 North, Range 8 East. The Town Limits on the West side of said highway 56 right of way begin at a point located on the Northeast Corner of the Northeast Quarter of the Southeast Quarter of Section 9, Township 10 North, Range 8 East then said strip advances Northward on State Highway 56 right of way until the point of the Southeast corner of the Northeast Quarter, Section 33, Township 11 North, Range 8 East; thence West along the South Line of said NE/4 a distance of 500' (along South property line of the Stuckeys Pecan Shop of Cromwell, Inc.); thence North and parallel to the East Line of said NE/4 to a point 33' South of the North Line of said NE/4; (EW 112), Thence East and parallel to the North Line of Section's 33 and 34, Township 11 North, Range 8 East (EW 112) a distance of 1,000', said point being 33' South of the North Line of said Section 34; Thence South and parallel to the West Line of said Section 34 to a point on the South Line of the NW/4 of said Section 34; Thence West along said South Line for a distance of 500' to the point of beginning.




