AN ORDINANCE OF THE MAYOR AND COUNCIL OF THE CITY OF DEWEY, OKLAHOMA, ANNEXING A TRACT OF LAND LOCATED NORTH 412 FEET OF SOUTH 720 FEET OF NORTH 750 FEET OF EAST 706.64 FEET OF WEST 1420 FEET OF NORTH 1/2 NORTHEAST OF SECTION 21, TOWNSHIP 27 NORTH, RANGE 13 EAST AND SOUTH 308.22 FEET OF NORTH 770' OF EAST 706.64 FEET OF WEST 1420 FEET OF NORTH 1/2 NORTHEAST OF SECTION 21, TOWNSHIP 27 NORTH, RANGE 13 EAST IN THE CORPORATE CITY LIMITS OF DEWEY, OKLAHOMA, WASHINGTON COUNTY, OKLAHOMA.

BE IT ORDAINED BY THE MAYOR AND COUNCIL OF THE CITY OF DEWEY, OKLAHOMA; AND DECLARING AN EMERGENCY.

Section 1. A petition for annexation has been filed with the City of Dewey, Washington County, Oklahoma to annex the following described property all situated in Washington County, Oklahoma, State of Oklahoma, and more particularly described as follows: A tract of land located North 412 feet of South 720 feet of North 750 feet of East 706.64 feet of West 1420 feet of North 1/2 Northeast, Section 21, Township 27 North, Range 13 East and South 308.22 feet of North 770 feet of East 706.64 feet of West 1420 feet of North 1/2 Northeast, Section 21, Township 27 North, Range 13 East into the corporate City Limits of Dewey, Oklahoma.

Section 2. It has been determined that the petitioners constitute three/fourths of the registered owners in value of land located within the geographical limits on the property above described.

Section 3. The real property above described in Section 1 hereof is hereby annexed into and made a part of the Corporate City Limits of the City of Dewey, Oklahoma.

Section 4. That the real property above described shall have a zoning classification of M-2, General Industrial District.

Section 5. The real property above described shall become and be from and after the date hereof a part of Ward 1 of the City of Dewey.

Section 6. All ordinances or portions of ordinances in conflict herewith are hereby repealed insofar that such conflict exists.

Section 7. It being necessary for the preservation of the public peace, health and safety of the City of Dewey, Oklahoma and the inhabitants thereof, an emergency is hereby declared to exist. By reason whereof it is necessary that this ordinance go into full effect and be of force immediately upon its passage and approval.



