BE IT ORDAINED BY THE MAYOR AND COUNCIL OF THE CITY OF DEWEY, OKLAHOMA;

Section 1. A petition for annexation has been filed with the City of Dewey, Washington County, Oklahoma to annex the following described property all situated in Washington County, Oklahoma, State of Oklahoma, and more particularly described as follows:

Section 2. The City finds the above-described property is actually touching corporate limits. (11 O.S., Section 21-101)

Section 3. It has been determined that the petitioners constitute three-fourths of the registered owners in value of land located within the geographical limits on the property above described.


Section 4. The real property above described in Section 1 hereof is hereby annexed into and made a part of the Corporate City Limits of the City of Dewey, Oklahoma.

Section 5. The real property above described shall have a zoning classification of RS-7, Single Family Residence District.


Section 6. The real property above described shall become and be from and after the date hereof a part of Ward 4 of the City of Dewey.


