

ORDINANCE #2013-1520

AN ORDINANCE ANNEXING A PORTION OF SECTION 21 OF TOWNSHIP 27 NORTH, RANGE 13 EAST, WASHINGTON COUNTY, OKLAHOMA, INTO THE CITY LIMITS OF DEWEY, OKLAHOMA; ESTABLISHING ZONING; AND DECLARING AN EMERGENCY.

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF DEWEY, OKLAHOMA, AS FOLLOWS:

Section 1. A petition for annexation has been filed with the City of Dewey, Washington County, Oklahoma, to annex the following described real property all situated in Washington County, State of Oklahoma, and more particularly described as follows:

BEG 420' S OF NW COR SE SW; S 132.5'; E 234'; NE ALONG RIGHT-OF-WAY FOR 178'; W 350' TO THE BEG: SEC:21 TOWNSHIP:27N RANGE:13E. ALSON KNOW AS 1120 N. FRONT

THE S 47.5' OF TRACT BEG 420' S OF NW CORNER SE SW; S 180'; E 165'; NE ALONG RIGHT-OF-WAY FOR 278'; W 350' TO THE BEG: SEC:21 TOWNSHIP:27N RANGE: 13E. ALSO KNOWN AS 1114 N FRONT

into the Corporate City Limits of Dewey, Oklahoma.

Section 2. It has been determined that the petitioners constitute 3/4 of the registered voters and owners, in value, of land located within the geographical limits of the property above described.


Section 3. The real property above described in Section 1 is hereby annexed into and made a part of the Corporate City Limits of the City of Dewey, Oklahoma.

Section 4. The real property above described, and which is located in Section 21, Township 27, Range 13 East, Washington County, Oklahoma, shall have a zoning classification of RS-5.

Section 5. The real property above described shall become and be from and after the date hereof a part of Ward 1 of the City of Dewey.

Section 6. WHEREAS, FOR THE PRESERVATION OF THE PUBLIC PEACE, HEALTH AND SAFETY, AN EMERGENCY IS HEREBY DECLARED TO EXIST. BY REASON WHEREOF THIS ORDINANCE SHALL BE IN FULL FORCE AND EFFECT FROM AND AFTER ITS PASSAGE AND APPROVAL.

PASSED BY THE CITY COUNCIL AND APPROVED BY THE MAYOR OF THE CITY OF DEWEY, OKLAHOMA, AND THE EMERGENCY VOTED ON SEPARTELY AND BY UNANIMOUS VOTE PASSED THIS 2ND DAY OF DECEMBER, 2013.


