BE IT ORDAINED BY THE GOVERNING BODY OF THE TOWN OF DIBBLE, OKLAHOMA:

Article One That pursuant to 11 O.S. §21-101 for the public purpose of guiding and enhancing development of the Town of Dibble, Oklahoma the following described real estate shall be and hereby is annexed to the Town of Dibble, Oklahoma:

In McClain County, State of Oklahoma, Beginning at a Point of Beginning located at the intersection of the center of the right-of-way of State Highway 39 and the centerline of MacArthur Road, then extending west to the west line of the east one-half of Section 4 of Township Six North Range Four West, thence south to the northeast corner of the northwest quarter of Section 9 of Township Six North Range Four West, thence west to the northwest corner of Section 9 of Township Six North Range Four West, thence south to the southwest corner of the southwest quarter of Section 21 of Township Six North Range Four West, thence east to the southeast corner of the southeast quarter of Section 21 of Township Six North Range Four West, thence north to the Point of Beginning, said area referred to hereinafter as "Annexed Area".

Article Two. That it is determined and declared that in compliance with requirements of 11 O.S. §21-102 that Annexed Area is contiguous or adjacent to present municipal limits of Town of Dibble;

Article Three That it is determined and declared that Annexed Area is not heretofore incorporated into the corporate municipal limits of any city or town;

Article Four That it is determined and declared that legal notice has been provided to all parties required to be notified pursuant to laws of the State of Oklahoma, including public hearing and adoption of Service Plan;

Article Five That it is determined and declared that the fair market value of the property proposed to be annexed is less than that presently within the municipal corporate limits of the Town of Dibble, such values as determined by reference to current tax rolls of Office of McClain County Treasurer;


Article Six That it is determined and declared that there is and has been no ad valorem taxation

is currently or imposed by Town of Dibble and therefore that no real estate parcel included within annexed area shall have *ad valorem taxes* imposed by result of this annexation.

Article Seven That the map attached hereunto is incorporated herein and shall be provided to County of McClain County, to Oklahoma Department of Transportation, and to such other parties as required by state law.


Article Eight That this ordinance shall become effective thirty days after its being published twice in the *Blanchard News*.




