

ORDINANCE NO 1106

AN ORDINANCE OF THE CITY OF ELK CITY, OKLAHOMA ANNEXING AN 8.19 ACRE TRACT OF PROPERTY IN THE SOUTHWEST QUARTER OF SECTION 25, TOWNSHIP 11 NORTH, RANGE 21 WIM, BECKHAM COUNTY, OKLAHOMA; CLASSIFYING THE ZONING THEREOF; CLASSIFYING THE WARD THEREOF.

AND WHEREAS, it is the best interests of the citizens of Elk City, Oklahoma, that orderly annexation of property adjacent or contiguous to the city limits be carried out;

NOW THEREFORE, BE IT ORDAINED BY THE MAYOR AND CITY COMMISSION OF THE CITY OF ELK CITY, OKLAHOMA:

1. That the following described property should be and the same is hereby annexed to and incorporated within the corporate city limits of Elk City, Oklahoma and assigned the corresponding zoning and ward classification set forth below:

A Tract of land in the Southwest Quarter (SW¼) of Section 25, Township 11 North, Range 21 West of the Indian Meridian, lying South of the South right-of-way line of the CRI & P Railroad, being described by meets and bounds as follows: Beginning at the Southwest Corner of the said Southwest Quarter of Section 25, thence North and along the West line of said Southwest Quarter for 321.17 feet, thence North 89°48'27" East for 1089.0 feet; thence South for 333.98 feet; thence North 89°31'07" West and along the South line of said Southwest Quarter for 1089.08 feet to the point of beginning, containing 8.19 acres, more or less, less and except all of the oil, gas and other minerals;


Zoning: A-1, Agricultural District




