

**ORDINANCE NO. 2011-01**



**AN ORDINANCE EXTENDING THE CORPORATE LIMITS OF THE CITY OF ENID, OKLAHOMA, BY ACTION OF THE GOVERNING BODY OF THE CITY OF ENID, PURSUANT TO THE CONSENT OF PRAIRIE DEVELOPMENT, LLC (THE OWNER OF THE PROPERTY TO BE ANNEXED); DESIGNATING THE AREA INCLUDED IN THE EXTENSION; PROVIDING FOR AUTHORITY FOR SUCH EXTENSION AND ANNEXATION; PROVIDING REPEALER, SAVINGS CLAUSE AND SEVERABILITY AND DECLARING AN EMERGENCY.**

**EMERGENCY ORDINANCE**

NOW THEREFORE, BE IT ORDAINED BY THE MAYOR AND BOARD OF COMMISSIONERS OF THE CITY OF ENID, OKLAHOMA:

Section I. Property Annexed by Action of the Governing Board: The corporate limits of the City of Enid, Oklahoma shall be extended to include and thereby annex the property shown by the map entitled "Exhibit A" and further described below:

The southwest quarter of Section 34, Township 23 North, Range 7 West, Indian Meridian, Garfield County, Oklahoma.

Section II. REPEALER. All ordinances or parts thereof which are inconsistent with this ordinance are hereby repealed.

Section III. AUTHORITY. The Mayor and Board of Commissioners have received consent by Prairie Development, LLC, the owner of the property to be annexed, to annex the property described above. This annexation by the governing body is authorized by 11 Okla. Stat. §§ 21-101 and 21-103.

Section IV. SAVINGS CLAUSE. Nothing in this ordinance hereby adopted shall be construed to affect any suit or proceeding now pending in any court, or any rights acquired or liability incurred nor any cause or causes of action accrued or existing, under any act or ordinance repealed hereby. Nor shall any right or remedy of any character be lost, impaired or affected by this ordinance.

Section V. SEVERABILITY. The invalidity of any section or provision of this ordinance shall not invalidate other sections or provisions thereof.






